EXPLANATIONS

1. (c)

Statements 1 and 2 are correct: The 'Adopt a Heritage: ApniDharohar, ApniPehchaan' scheme is an initiative of the Ministry of Tourism, in collaboration with the Ministry of Culture and the Archaeological Survey of India. The scheme was launched on World Tourism Day, i.e., 27 September 2017. The Adopt a Heritage Scheme allowed public and private sector enterprises to acquire top heritage areas of India and enhance tourism activities there. The sites/monuments are selected on the basis of tourist footfall and visibility and can be adopted by private and public sector companies and individuals — known as Monument Mitras— for an initial period of five years.

2. (b)

Statement 1 is not correct. Bhunga houses are traditional houses, a unique type of round mud hut walled with thatched roof.

Statement 2 is correct These houses are commonly called **'Architecture without Architect'** because of the superior architectural knowledge gained by the locals through the years.

Statement 3 is correct The reworked design of bhungas that is about 200 years old stood very firm during the earthquake of 2001 when it was very close to the epicenter.

3. (c)

Statements 1 is correct: Nanakshahi Sammat 555 is a calendar system that was introduced by the Shiromani Gurdwara Parbandhak Committee (SGPC) in 2003.

Statement 2 is correct: It is named after the founder of the Sikh religion, Guru Nanak Dev Ji to mark his 500th birth anniversary. It is a tropical solar calendar used in Sikhism.

The Nanakshahi calendar is used by Sikhs around the world to mark important dates and festivals in the Sikh calendar, including the birth anniversaries of the ten Sikh Gurus, the martyrdom of Guru Arjan Dev, and the anniversary of the founding of the Khalsa Panth.

4. (c)

Statement 1 is not correct: Carnatic music or Carnatic sangeet is the south Indian classical music.

It has developed in the south Indian states of Tamil Nadu, Kerala, Andhra Pradesh and Karnataka. These states are known for their strong presentation of Dravidian culture.

Statement 2 is correct: Purandardas is considered to be the father of Carnatic music.

Statement 3 is correct: In Carnatic music there is a very highly developed theoretical system. It is based upon a complex system of Ragam (Raga) and Thalam (Tala). Raga is basically the scale and the seven notes of this scale are Sa Re Ga Ma Pa Dha and Ni.

Statement 4 is not correct: The Tala (thalam) is the rhythmic foundation of Carnatic music.

5. (c)

Statement 1 is correct: Location: Sharda Peeth, a revered site for the Hindu community, is located in **Neelum Valley** in Pakistan Occupied Kashmir (PoK) across Teetwal village in Kupwara district of Jammu and Kashmir, along the Line of Control (LoC).

Statement 2 is not correct: Cultural Importance: The ancient temple of Sharda (also spelt Sharada or Sarada) is one of the 18 Maha Shakti Peethas and is considered to be the abode of **Hindu Goddess Saraswati**.

Statement 3 is not correct: Sharda University: Close to the temple, the ruins of one of the world's oldest universities can be found. It is believed that Sharda University had its own script known as Sharada and it had over 5,000 scholars and the biggest library.

Statement 4 is correct: Once upon a time, Sharda Peeth was considered the centre of knowledge in the Indian subcontinent, scholars from all over the country used to come here in search of scriptures and spiritual knowledge.

EXPLANATIONS

1. (a)

In News: Recently, the National Stock Exchange of India received final approval from the markets regulator Securities and Exchange Board of India (SEBI) to set up a Social Stock Exchange (SSE).

Statement 1 is correct: Social Stock Exchange (SSE): The SSE would function as a separate segment within the existing stock exchange and help social enterprises raise funds from the public through its mechanism.

• It would serve as a **medium for enterprises** to seek finance for their social initiatives, acquire visibility and provide increased transparency about fund mobilisation and utilisation.

Statement 2 is not correct: Finance Minister Nirmala Sitharaman, presenting the Union Budget back in 2019, had proposed to initiate steps for creating a stock exchange under the market regulator's ambit.

• The proposal was cleared in September 2021

2. (a)

Statement 1 is correct: The Central Electricity Authority (CEA) is a statutory organisation constituted under Section 3 (1) of the repealed Electricity (Supply) Act, 1948 and continued under Section 70 of the Electricity Act, 2003.

Statement 2 is correct: CEA is responsible for concurrence of hydro power development schemes of central, state and private sectors for efficient development of the river and its tributaries for power generation.

Statement 3 is not correct: CERC (Central Electricity Regulatory Commission) (not CEA) regulates tariffs of power generating companies of the Central Government. CERC also manages companies which follow interstate energy transmission and composite schemes for power generation.

3. (a)

Fugitive Economic Offenders Act, 2018

India has put in place specialized legislation in the form of the Fugitive Economic Offenders Act, 2018.

- **Definition of FEO:** The 'fugitive economic offender' (FEO) is defined as an individual against whom a warrant of arrest in relation to scheduled offence has been issued by any court in India and who has left the country so as to avoid criminal prosecution; or the FEO abroad, refuses to return to face criminal prosecution.
- **Aim:** The Act aims to help confiscate assets of high-value economic offenders absconding from India till they submit to the jurisdiction of the appropriate legal forum. **Hence statement 1 is correct.**

• Procedure to be followed:

- The investigating agencies have to file an application in a Special Court under the Prevention of Money-Laundering Act containing details of the properties to be confiscated, and any information about the person's whereabouts.
- The Special Court will issue a notice for the person to appear at a specified place and date at least six weeks from the issue of notice.
 - If the person appears:
- Proceedings will be terminated **if the person appears**.
 - If the person does not appear:
- If not the person would be **declared as a Fugitive Economic Offender** based on the evidence filed by the investigating agencies.
- The person who is declared as a Fugitive Economic Offender **can challenge the proclamation** in the High Court within 30 days of such declaration according to the Fugitive Economic Offenders Act, 2018. **Hence statement 2 is incorrect.**

4. (d)

Ornamental fish aquaculture:

- Community-based ornamental fish aquaculture, using local resources is the first-of-its-kind experiment, as many as 82 islanders from Lakshadweep, 77 of them women, were selected and underwent intensive training.
- The NBFGR maintains a germplasm resource center for marine ornamental organisms on Agatti Island for conservation as well as boosting livelihood sources for the islanders.
- The support being extended by the NBFGR includes capacity **building and hand-holding community aquaculture units** maintained by local women to raise captive-bred marine ornamentals, including shrimps, to marketable size.
- The **NBFGR project team on Agatti island** will **monitor** the units and **provide technical inputs**, till the organisms reach the marketable size.

5. (c)

Money laundering laws will now cover cryptocurrency trade:

- The Finance Ministry said the anti-money laundering legislation has been applied to crypto trading, safekeeping and related financial services.
 - The notification said,
- Exchange between virtual digital assets and fiat currencies,
- Exchange between one or more forms of virtual digital assets,
- Transfer of virtual digital assets, safekeeping or administration of virtual digital assets or instruments enabling control over virtual digital assets, and participation in and
- Provision of financial services related to an issuer's offer and sale of a virtual digital asset"
 - All of the above will now be covered by the Prevention of Money-laundering Act, 2002.
- Virtual digital assets:
 - Virtual digital assets were defined as any code or number or token generated through cryptographic means with the promise or representation of having inherent value.

6. (a)

Statement 1 is correct LDCs are **low-income countries** confronting severe structural impediments to sustainable development. They are **highly vulnerable to economic and environmental shocks** and have low levels of human assets.

Statement 2 is correct There are currently 46 countries on the list of LDCs which are reviewed every three years by the Committee for Development (CDP).

Statement 3 is not correct Following countries are scheduled to graduate from LCDs status in coming years:

- Angola (2024)
- Bangladesh (2026)
- Bhutan (2023)
- Lao People's Democratic Repu<mark>blic</mark> (2026)
- Nepal (2026)
- Sao Tome and Príncipe (2024)
- Solomon Islands (2024)
- 7. (c)

G-SIBs

- Basel-based Financial Stability Board (FSB), an initiative of G20 nations, in consultation with Basel Committee on Banking Supervision (BCBS) and national authorities, identified the list of global systemically important banks (G-SIBs). Hence statement 1 is correct.
- There are 30 G-SIBs as of now.
 - O They include JP Morgan, Citibank, HSBC, Bank of America, Bank of China, Barclays, BNP Paribas, Deutsche Bank and Goldman Sachs.
- However, no Indian bank figures in the G-SIB list. Hence statement 2 is correct.
- 8. (c)

Six countries have graduated from least developed country status:

- Botswana in December 1994
- Cabo Verde in December 2007
- Maldives in January 2011
- Samoa in January 2014

- Equatorial Guinea in June 2017
- Vanuatu in December 2020

Bangladesh and Nepal are scheduled to graduate in 2026.

9. (b)

The NSSO was set up in 1950 to conduct large-scale sample surveys throughout India. In 2019 the government created an overarching body - National Statistical Office (NSO) through the merger of the NSSO and the CSO. **Hence statement 1 is not correct**

- Consumer Price Index measures price changes from the perspective of a retail buyer. There are four types of CPI
 - CPI for Industrial Workers (IW).
 - CPI for Agricultural Labourer (AL).
 - CPI for Rural Labourer (RL).
 - CPI (Rural/Urban/Combined).
- The first three indices are compiled by the Labour Bureau in the Ministry of Labour and Employment. Fourth is compiled by the NSO in the Ministry of Statistics and Programme Implementation. Hence statement 2 is correct.

10. (b)

Statement 1 is not correct The PM MITRA scheme is Inspired by the 5F vision - Farm to Fibre to Factory to Fashion to Foreign.

Statement 2 is correct It aspires to fulfil the vision of building an Aatmanirbhar Bharat and to position India strongly on the Global textiles map.

Statament 3 is correct PM MITRA Parks offer an opportunity to create an **integrated textiles value chain** right from spinning, weaving, processing/dyeing and printing to garment manufacturing at 1 location.

• Integrated Textile Value chain at 1 location will reduce logistics cost of Industry.

- 11. (c)
 - Sablang method is used in **sugarcane farming.** Plants are grown in fertile soil with wide spacing, shallow planting, frequent irrigation, and adequate fertilisation. The Offshoots are removed carefully from the mother plant as soon as they develop their own roots and are transplanted in the main field.
- 12. (d)
 - Statement 1 is not correct: According to the MIS survey, less than a quarter of rural households and under two-thirds of urban ones in India reported having piped water for drinking in their houses or yard.
 - Although penetration of piped drinking water is abysmal in many states, more than 95.7% of people reported having access to an improved source of drinking water.
 - Statement 2 is not correct: The MIS survey confirms the progress in financial inclusion in India with nearly 90% of those surveyed reporting having an account individually or jointly with banks, other financial institutions or mobile money service providers.

13. (d)

Statement 1 is correct: India ranks 135 among a total of 146 countries in the World Economic Forum's Global Gender Gap Index 2022, which slipped from 112th position in 2020.

• According to the **World Bank, from 30.7% in 2006,** the proportion of working age women taking part in paid work dropped to **19.2% in 2021**.

Statement 2 is correct: The proportion of women employees has **increased** over the past year in most of public sector banks. **Indian Overseas Bank had the highest** share of female staffers in their total staff strength at 36%.

Statement 3 is correct: Equal Remuneration Act, 1976; Factories (Amendment) Act, 1948 seek to provide equality and fairness in women working conditions.

14. (c)

Recently, the 11th edition of the World Happiness Report was released by the UN Sustainable Development Solutions Network (SDSN). For the sixth year running, Finland was named the world's happiest country. India was ranked 126 of the 137 countries on the list.

• The report usually ranks 150 countries based on several factors such as real GDP per capita, social support, healthy life expectancy, freedom to make life choices, generosity and perceptions of corruption.

15. (a)

Statement 1 is not correct: In May 2016, **Ministry of Petroleum and Natural Gas (MOPNG)**, introduced the 'Pradhan Mantri Ujjwala Yojana' (PMUY) as a flagship scheme with an objective to make clean cooking fuel such as LPG available to the rural and deprived households

Statement 2 is correct: An adult woman belonging to a poor household and not having LPG connection in her household, will be eligible under UJJWALA 2.0. The beneficiaries should belong to any of the following categories:

- Eligible as per SECC 2011 list.
- Belongs to SC/ST households, be a beneficiary of Pradhan Mantri Awas Yojana (PMAY), Antyodaya Anna Yojana (AAY), Forest dwellers, Most Backward Classes (MBC), Tea and Ex-Tea Garden Tribes, People residing in river Islands (Beneficiary will submit supporting document).
- If she is not falling in the above 2 categories, then she can stake her claim to be a beneficiary under Poor household by submitting 14-point declaration (as per prescribed format).

16. (c)

PM MITRA Scheme

- The seven Mega Integrated Textile Region and Apparel (PM MITRA) parks will be set up at Greenfield or Brownfield sites located in different states.
- It will be **developed by a Special Purpose Vehicle (SPV)**, which will be **owned by the State Government** and the **Government of India** in a Public-Private Partnership **(PPP) Mode**.

17. (d)

Statement 1 is not correct: The **Essential Commodities Act 1955** was introduced to address the problem of food scarcity during that period in India. The act was enacted to stop the hoarding and black marketing of food items. Essential commodities are **not specifically defined in the Essential Commodities Act, 1955**, but Section 2(A) of the act underlines that an "essential commodity" means a commodity mentioned in the Schedule of the Act.

• The Union government derives its **power to add or remove a commodity specified in the schedule from this act.**

Statement 2 is not correct: The Central Government in consultation with state governments can notify an item as essential. The government can control the production, supply, and **distribution of the declared essential commodity and can also impose a stock limit.**

18. (a)

Statement 1 is not correct: SEBI is a **statutory body** established on April 12, 1992 in accordance with the provisions of the Securities and Exchange Board of India Act, 1992 in the **seventh five year plan**. **Statement 2 is not correct:** SEBI regulates the commodity derivatives market in India **since 2015**.

Statement 3 is correct: SEBI is a **quasi-legislative and quasi-judicial body** which can draft regulations, conduct inquiries, pass rulings and impose penalties.

19. (b)

Statement 1 is correct Political parties issue whips to their MPs to either vote for or against the bill, depending on their party line. Once the whip is issued, the MPs from each party will **necessarily have to obey the whip** or else risk losing their seat in Parliament.

Statement 2 is correct The whip **is an official appointed** to maintain discipline among, secure attendance of, and give necessary information to, members of his party.

- They are expected to be a **channel of communication** between the political party and the members of the party in the legislature.
- They also serve the **function of gauging the opinion** of the members, and communicating it to party leaders.

Statement 3 is not correct There can be 3 Types of Whips

- A one-line whip, underlined once, is usually issued to inform party members of a vote, and allows them to abstain in case they decide not to follow the party line.
- A two-line whip directs them to be present during the vote.
- A three-line whip is the strongest, employed on important occasions such as the second reading of a Bill or a no-confidence motion, and places an obligation on members to toe the party line.

2. (c)

Disqualification on ground of defection: A legislator belonging to a political party will be disqualified if he

- o (i) voluntarily gives up his party membership, or
- (ii) votes/abstains to vote in the House **contrary to the direction** issued by his political party.
- A member is not disqualified if he has taken **prior permission** of his party, or if the voting or abstention is condoned by the party within 15 days. **Hence statement 1 is correct.**
- Independent members will be disqualified if they join a political party after getting elected to the House.
- Nominated members will be disqualified if they join any political party six months after getting nominated. Hence Statement 2 is correct.

3. (b)

Statement 1 is not correct: The Joint Parliamentary committee (JPC) is an ad-hoc body which is set up for a given period of time and is aimed at addressing a specific issue not limited to only bills and dissolved after submission of its report to Parliament.

Statement 2 is not correct: The first JPC was formed in August 1987 to investigate the Bofors scandal. It was formed on a motion moved by the then defence minister K.C. Pant in the Lok Sabha on August 6, 1987.

Statement 3 is correct: Joint parliament committees are set up by a motion passed in one house of Parliament and agreed to by the other. The details regarding membership and subjects are also decided by Parliament. For example, the motion to constitute a JPC on the stock market scam (2001) and pesticide residues in soft drinks (2003) was moved by the government in the Lok Sabha.

4. (c)

Statement 1 is correct: It was established by amending Article 338 and inserting a new Article 338A in the Constitution through the Constitution (89th Amendment) Act, 2003.

Statement 2 is correct: Powers of the Commission: For Investigation and Inquiry, the Commission is vested with powers of a civil court having authority to:

- O Summon and enforce attendance of any person and examine on oath;
- O Discovery & production of any documents;
- Receive evidence on affidavits;
- Requisition any public record or copy thereof from any court or office;
- o Issue Commissions for examination of witnesses and documents; and
- O Any matter which President, by rule, may determine.

5. (a)

Statement 1 is correct: As per the rules under the Forest Rights Act, 2006 **'Gram Sabha' is an important entity** within the act's tools to achieve its objective.

Statement 2 is not correct: The FC Rules, 2022 do not require the collector to obtain the consent of Gram Sabhas before the In-principle approval.

• This means, the Central Government can give its final approval and will, thereafter, leave it to the state government to pass an order for de-reservation or diversion or assignment. It is then left to the **state government** now to **make sure that the claims of forest dwellers are settled**.

6. (c)

Statements 1 is not correct: The Special Marriage Act, 1954 is an Act of the Parliament of India with provision for civil marriage for people of India and all Indian nationals in foreign countries,

Statement 2 is correct: The act provides for the registration of marriage irrespective of religion or faith followed by either party.

Statement 3 is correct: The couples have to serve a notice with the relevant documents to the Marriage Officer 30 days before the intended date of the marriage.

7. (b)

Statement 1 is not correct. Rajasthan's Right to Health Bill provides the right to health and access to healthcare for people in the state. This includes free health care services at any clinical establishment to residents of the state including private establishments.

Statement 2 is correct Health Authorities will be set up at the state and district level. These bodies will formulate, implement, monitor, and develop mechanisms for quality healthcare and management of public health emergencies.

8. (a)

Statements 1 is correct: The BCI is a **statutory body** established under the **section 4 of Advocates Act 1961** that regulates the legal practice and legal education in India.

Statement 2 is correct: It consists of members elected from each state bar council, and the Attorney General of India and the Solicitor General of India who are ex officio members.

Statement 3 is not correct: One of its functions is to recognise foreign qualifications in law obtained outside India for admission as an advocate.

9. (d)

Pair 1 is correctly matched Mahabir Prasad Judgement: The case revolved around the question of the nature of the governor's pleasure under article 164(1).

- The withdrawal of the governor's pleasure must coincide with the withdrawal of support to the ministry by the assembly.
- Pair 2 is correctly matched Nabam Rebia Judgement: SC ruled that Article 163 of the Constitution does not give the Governor a general discretionary power to act against or without the advice of his Council of Ministers.
- Minerva Mills case: The judgement struck down 2 changes made to the Constitution by the 42nd Amendment Act 1976, declaring them to be violative of the basic structure hence, Pair 3 is correctly matched
- **Pair 4 is correctly matched MC Mehta:** SC held that its power under **Article 32** is not restricted to preventive measures, but also remedial measures when rights are violated.

10. (a)

Statement 1 is correct: The procedure and conduct of business in Parliament is regulated by rules made under Article 118 of the Constitution and, in relation to certain financial business, by law made by Parliament under Article 119 of the Constitution. (No such law has so far been made by Parliament under Article 119.) Statement 2 is correct: Rule 357 procedure and conduct of business in Parliament deals with Personal explanation.

Statement 3 is not correct: Personal explanation states that a member may, with the **permission of the Speaker**, make a personal explanation although there is **no question** before the House, but in this case no debatable matter may be brought forward, and no debate shall arise.

Statement 4 is not correct: Rules were modified and adopted by the Speaker of Lok Sabha in exercise of the powers conferred on the Speaker by article 118(2) of the Constitution.

11. (c)

In News: Recently, The Goods and Services Tax (GST) Council, approved the creation of a national tribunal for the redressal of GST disputes.

- The 102nd Amendment Act inserted Articles 338B and 342A into the Indian Constitution.
 - Article 338B deals with the structure, duties and powers of the National Commission for Backward Classes (NCBC).
 - Article 342A deals with the power of the President of India to notify a particular caste as a Socially and Educationally Backward Class (SEBC) and the power of the Parliament to change the list.
 - The amendment also brings about changes in Article 366.
 - This amendment gave the NCBC a constitutional status. The Commission was originally set up in 1993.
 - The One Hundred and Fourth Amendment of the Constitution of India, extends the deadline for the cessation of the reservation of seats for members from Scheduled Castes and Scheduled Tribes in the Lok Sabha and State Legislative Assemblies by a period of 10 years.

Hence pair 1 is incorrectly matched

Pairs 2, 3 and 4 are correctly matched

- The 101st Amendment Act led to Article 246A in the constitution which operationalised GST.
- The 92nd Amendment Act amended the Eighth Schedule to the Constitution so as to include Bodo, Dogri, Maithili and Santali languages. The Eighth Schedule to the Constitution originally included 14 languages. Sindhi was included by the 21st Amendment, enacted in 1967; and Konkani, Meitei and Nepali were included by the 71st Amendment in 1992.
- The 61st amendment act amended Article 326 of the Constitution to reduce the voting age from 21 years to 18 years.
- 12. (b)

Lily Thomas v Union of India & disqualification of MPs

- Section 8(4):
 - It states that the **disqualification** takes effect only "**after three months have elapsed**" from the date of conviction. Within that period, MP can file an appeal against the sentence before the High Court.
 - Lily Thomas v Union of India: While the law had initially provided for a pause on disqualification if an appeal against the conviction was filed before a higher court, in the landmark 2013 ruling in 'Lily Thomas v Union of India', the Supreme Court struck down Section 8(4) of the RPA as

unconstitutional.

13. (d)

- Statement 1 is not correct: An order under Section 144 can be for a particular individual or to the public generally.
 - Section 144 CrPC prohibits such activities or actions which are generally allowed on normal, regular days. It is imposed to maintain peace and tranquillity in an area
- Statement 2 is not correct: An order under section 144 may be passed even ex-parte (after implementation) if there is an emergent situation or if circumstances do not allow the serving of due time to the person against whom the order has been made. Any order under this section shall remain in force for not more than two months.

14. (b)

Statement 1 is correct: It is the **apex body** in India for the formulation, coordination and promotion of biomedical research, and is one of the oldest medical research bodies in the world.

Statement 2 is not correct: In 1911, the Government of India set up the Indian Research Fund Association (IRFA) with the specific objective of sponsoring and coordinating medical research in the country.

It was redesignated the Indian Council of Medical Research (ICMR) in 1949.

Statement 3 is not correct: The governing body of the council is presided over by the Union Health Minister. It is assisted in scientific and technical matters by a scientific advisory board comprising eminent experts in different biomedical disciplines

Statement 4 is not correct: The ICMR is funded by the Government of India through the Department of Health Research, Ministry of Health and Family Welfare.

15. (d)

The affinity test: An affinity test mandates the study and preparation of a report by authorities on caste/tribe claims based on the peculiar anthropological and ethnological traits, deities, rituals, customs, mode of marriage, death ceremonies, methods of burial of dead bodies, etc., of the particular caste or tribe and the applicants knowledge of them.

- But the Supreme court recently said that an **"affinity test can never be conclusive"** to prove a caste/tribe claim.
- It stated that an affinity test is not an essential part of the process of the determination of the correctness of a caste or tribe claim in every case.

16. (a)

Statement 1 is correct: Article 110 of the Constitution deals with the Money Bills. It states that a bill is deemed to be a money bill if it contains 'only' provisions dealing with all or any of the following matters:

- The imposition, abolition, remission, alteration or regulation of any tax;
- The regulation of the borrowing of money by the Union government;
- The custody of the Consolidated Fund of India or the contingency fund of India, the payment of moneys into or the withdrawal of money from any such fund;
- The appropriation of money out of the Consolidated Fund of India;
- Declaration of any expenditure charged on the Consolidated Fund of India or increasing the amount of

any such expenditure;

- The receipt of money on account of the Consolidated Fund of India or the public account of India or the custody or issue of such money, or the audit of the accounts of the Union or of a state; or
- Any matter incidental to any of the matters specified above.

Statement 2 is not correct: Rajya Sabha can **suggest amendments** to the money bill but it's up to the Lok Sabha to consider these amendments or not. At most rajya sabha can delay it for a period of 14 days.

EXPLANATIONS

1. (a)

El Niño:

- El Niño is the warming of seawater in the central-east Equatorial Pacific that occurs every few years.
 - Forecasts for the **2023 fall and winter** are predicting that **El Niño**, will occur with more than a **50% probability**.
- Outcomes:
 - Increase in the planet's average surface temperature:
 - An El Niño year creates a global-warming crisis in miniature:
- This is because the warm water spreading across the tropical Pacific and releases a large amount of heat into the atmosphere.
 - An El Niño this year could increase the planet's average surface temperature **by more than 1.5° C** from pre-industrial levels. **Hence option 3 is correct.**
 - Transition of La Niña to El Niño:
 - A transition **from a La Niña winter** which we are in currently **to an El Niño summer** has historically tended to produce the largest deficit in the monsoon.
 - This means that pre-monsoon and monsoon circulations tend to be weaker in an El Niño year.
 - Weaker vertical shear:
 - The vertical shear, which is the change in intensity of winds from the surface to the upper atmosphere, tends to be weaker as well.
 - This in turn can favour enhanced cyclogenesis, i.e. cyclone formation. Hence option is 4 is correct and 2 is incorrect.
 - Monsoon Deficit & dry events:
 - If an El Niño state does emerge by summer, India is likely to experience a deficit monsoon in 2023.
 - The monsoon deficit will be accompanied by extreme wet and dry events.
 - While overall seasonal total could be deficient, there are likely to be isolated pockets of heavy or very heavy rainfall. Hence option 1 is correct.

2. (d)

The Adriatic Sea is a part of the Mediterranean Sea positioned between the eastern coastline of Italy, and countries of the Balkan Peninsula, from Slovenia, South through Croatia, Montenegro, and to Albania. Hence, pair 1 is correctly matched.

- The Celebes Sea is located in the western Pacific Ocean north of the Indonesian Island of Celebes and south of the Sulu Sea and the Philippines. Hence, pair 2 is correctly matched.
- The Molucca Sea is a part of the western Pacific Ocean, bounded by the Indonesian islands of Celebes (west), Halmahera (east), and the Sula group (south). Hence, pair 3 is correctly matched.
- Cyprus is an island country located south of the Anatolian Peninsula in the eastern Mediterranean Sea. Hence, pair 4 is correctly matched.

3. (b)

Option b is correct: Nearly half of the country's landslide-prone area (0.18 sq km) is located in the states of Assam, Arunachal Pradesh, Sikkim, Meghalaya, Mizoram, Manipur, Tripura and Nagaland.

• Mizoram, recorded the highest number of landslide events (12,385) in the past 25 years, of which 8,926 were recorded in 2017 alone.

• Uttarakhand has experienced the second highest number (11,219) of landslides since 1998, all events since occurring post 2000.

4. (c)

Statement 1 is correct. National Platform for Disaster Risk Reduction is a **multi-stakeholder platform** constituted by the Government of India in 2013 to facilitate dialogue, sharing experiences, views, ideas, action-oriented research & explore opportunities in the area of Disaster Risk Reduction (DRR).

Statement 2 is correct

Functions of National Platform for Disaster Risk Reduction

- To **review the progress** made in the field of disaster management from time to time.
- To appreciate the extent and manner in which the Disaster Management Policy has been implemented by the Central and State Governments, and other concerned agencies, and to give appropriate advice in the matter.
- To **advise on coordination** between the Central and State Governments/UT Administrations, local selfgovernments and civil society organizations for Disaster Risk Reduction.
- **To advice suo-moto or on a reference** made by the Central Government or any other State Government or a Union territory Administration on any question pertaining to disaster management.
- To review the National Disaster Management Policy.

5. (c)



• It is also known as the South Pennar River, **Dakshina Pinakini** in Kannada and Thenpennai or Ponnaiyar or Pennaiyar in Tamil.

6. (c)

East African Rift:

- The division of the continent is connected to the East African Rift, a crack that stretches 56 kilometres and appeared in the desert of Ethiopia in 2005.
- The crack has triggered the formation of a new sea.
- Division of the continents:
 - This geological process will inevitably divide the continent, resulting in currently landlocked countries, such as Uganda and Zambia, obtaining their own coastlines in due time, which would take five to 10 million years according to the study.
 - As the **Somali and Nubian tectonic plates** continue to pull apart from each other, a smaller continent will be created from the rift, which will include present-day **Somalia** and parts of **Kenya**, **Ethiopia**, and Tanzania.
 - The **Gulf of Aden and the Red Sea** will eventually **flood into the Afar region** in Ethiopia and the East African Rift Valley, **leading to the formation of a new ocean**.



7. (c)

Statements 1 and 3 are correct: GAC is an online dispute resolution mechanism. Users aggrieved by a decision of the Grievance Officer of an intermediary may file their appeal through the GAC's platform

- The GAC consists of a chairperson and two whole-time members appointed by the Central Government, of which one will be a member ex-officio and two will be independent members.
- Any person aggrieved by a decision of an intermediary's Grievance Officer may appeal to the Grievance Appellate Committee within 30 days of the receipt of communication from the Grievance Officer.

Statement 2 is not correct: GAC is established under the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021 ["IT Rules"], made under the Information Technology Act, 2000.

- The IT Rules and GAC aim to ensure a Safe & Trusted and Accountable Internet for Indian users.

In News: Recently, the government has decided to give a one-time option to select Central government employees to migrate to the Old Pension Scheme (OPS), who applied for jobs advertised before December 22, 2003.

• It is divided into five operational and two functional commands. Each Command is headed by an Air Officer Commanding-in-Chief with the rank of Air Marshal. Hence statement 1 is correct.

- 8. (c)
 - INS Androth is the **second in a series of eight Anti-Submarine Warfare Shallow Water Craft (ASW SWC)** built by Garden Reach Shipbuilders and Engineers in Kolkata.
 - Its primary role is to conduct anti-submarine operations in coastal waters, low intensity maritime operations and mine laying operations.

9. (a)

The National Security Act was passed by the Parliament in 1980 and has been amended several times since then. NSA "empowers the state to detain a person without a formal charge and without trial". Hence statement 1 is correct.

- Under it an administrative order is passed either by the Divisional Commissioner or the District Magistrate (DM) and not detention ordered by police based on specific allegations or for a specific violation of the law.
 Hence statement 2 is not correct.
- The DM who passes the detention order is protected under the Act: No prosecution or any legal proceeding can be initiated against the official who carries out the orders. Therefore, the writ of habeas corpus is the available remedy under the Constitution against the state's power of taking people into custody under the NSA. Hence statement 3 is not correct.

10. (a)

Statement 1 is correct: Following the Sepoy Mutiny of 1857, the British enforced the **Arms Act of 1878** disallowing any Indian from possessing firearms unless the British were convinced of his/her loyalty to the Crown. Post-Independence, this law was scrapped and the **Indian Arms Act, 1959** was passed.

Statement 2 is correct: In 2016, the Centre issued new Arms Rules, 2016, superseding the Arms Rules, 1962, whereby applying for an arms license, rifle club, association, or firing range required one to complete a safety training course involving safe handling and carrying procedures.

Exemptions

- Arms which are part of the ordinary equipment of any **sea-faring vessel or aircraft** are exempted under the Act.
- Sportspersons (international medallists/renowned shooters) are allowed to carry firearms for shooting practice. Hence, Statement 3 is correct.
- Persons who are under orders of the Central government, public servants or members of the National Cadet Corps (NCC) are also exempt from the provisions of this Act. Hence, Statement 4 is not correct.

11. (b)

- Swathi is a weapon locating phased array radar developed by India. It is a counter-battery radar designed to detect and track incoming artillery and rocket fire to determine the point of origin for counter-battery fire.
 - The WLR has been jointly developed by the Electronics and Radar Development Establishment (LRDE), a lab of the Defence Research and Development Organisation (DRDO) and Bharat Electronics Limited (BEL).

12. (d)

Tactical vs Strategic Nuclear Weapons

- Tactical nuclear weapons are small nuclear warheads and delivery systems meant to carry out a limited strike in a smaller area. On the other hand, strategic nuclear weapons are understood to mean those causing greater, large-scale damage. Hence, Statement 1 is not correct.
- Tactical nuclear weapons have a relatively short range and a much lower yield than strategic nuclear weapons which are capable of destroying whole cities. Hence, Statement 2 is not correct.

1. (b)

In News: Recently, The UK government reached a landmark deal with the European Union (EU) on post-Brexit trade rules that will govern Northern Ireland.

The 'Windsor Framework' will replace the **Northern Ireland Protocol**, which had proved to be among the thorniest of Brexit fall-outs, creating problems both **economic and political**. The framework has two crucial aspects – the introduction of a green lane and red lane system for goods that will stay in Northern Ireland and those that will go to the EU respectively; and the 'Stormont Brake', which allows Northern Ireland lawmakers and London to veto any EU regulation they believe affects the region adversely.

2. (b)

Option B is correct: At the 48th G-7 Summit, the U.S. along with G7 allies unveiled the ambitious Partnership for Global Infrastructure and Investment (PGII).

- The PGII is seen as the G7's counter to China's multi-trillion dollar Belt and Road Initiative (BRI) to build connectivity, infrastructure, and trade projects in Asia, Europe, Africa, and Latin America.
- Under the PGII, G7 will mobilize 600 billion dollars by 2027 to deliver infrastructure projects to developing and middle-income countries.

3. (c)

Statement 1 is correct: BIMSTEC is a regional organisation that was established on 06 June 1997 with the signing of the Bangkok Declaration.

- Initially known as BIST-EC (Bangladesh-India-Sri Lanka-Thailand Economic Cooperation), the organisation is now known as BIMSTEC and comprises seven Member States with the admission of Myanmar on 22 December 1997, and Bhutan and Nepal in February 2004.

About:

- Raisina Dialogue of 2023 was the eighth edition of the Dialogue held in New Delhi. Hence statement 3 is incorrect.
- It is organized on the lines of the Shangri La Dialogue which takes place annually in Singapore and is co-hosted by the Ministry of External Affairs (MEA) and the Observer Research Foundation (ORF).
 Hence statement 2 is incorrect.
- Raisina Hills:
 - The name of the dialogue is derived from Raisina Hills, the **place where India's seat of power resides**.
 - It is an area in Delhi where the Rashtrapati Bhavan, the Prime Minister's Office (PMO) and other important government offices are situated.

7. (b)

To counter China's dominance of the Indo-Pacific supply chain, the Trade Ministers of **India**, Japan, and Australia have formally launched the Supply Chain Resilience Initiative (SCRI). It aims to attract foreign direct investment to turn the Indo-Pacific into an "economic powerhouse" and to build a mutually complementary relationship among partner countries.

8. (a)

Statements 1 is correct: The Shanghai Cooperation Organization (SCO) is a permanent intergovernmental international organisation of Eurasian Nations with a secretariat in Beijing. It is a political, economic and military organisation that aims at maintaining peace, security and stability in the region. Shanghai Five emerged in 1996 from a series of border demarcation and demilitarization talks between 4 former USSR republics and China. Kazakhstan, China, Kyrgyzstan, Russia and Tajikistan were members of the Shanghai Five. With the accession of Uzbekistan in 2001, the Shanghai Five was renamed the SCO.

Statement 2 is not correct: The SCO Charter was signed in 2002 and entered into force in 2003. India and Pakistan both were initially observer states. Both were given full membership in 2017. 2021 SCO summit in Dushanbe agreed for Iran to join the SCO.

Belarus has also begun the membership process for SCO. The SCO currently comprises of eight Member States (China, India, Kazakhstan, Kyrgyzstan, Russia, Pakistan, Tajikistan and Uzbekistan), four Observer States interested in acceding to full membership (Afghanistan, Belarus, Iran, and Mongolia) and six "Dialogue Partners" (Armenia, Azerbaijan, Cambodia, Nepal, Sri Lanka.

9. (b)

Statement 1 is not correct: AUKUS is a trilateral security pact between Australia, the United Kingdom, and the United States. It aims to arm Australia with at least three Virginia class and AUKUS class conventionally armed nuclear submarines.

• The Five Eyes is an intelligence alliance comprising Australia, Canada, New Zealand, the United Kingdom, and the United States. Hence statement 2 is Correct.

10. (a)

The ICC is headquartered in The Hague, Netherlands. It was established under a **1998 treaty** called the **"Rome Statute"**. Hence statement 1 is correct.

- **Difference between ICC & ICJ:** Unlike the International Court of Justice (ICJ), which deals with countries and inter-state disputes, the **ICC prosecutes individuals. Hence statement 2 is correct.**

1. (a)

Option A is correct: Reinforcement learning: A method of teaching AI without specific metrics, encouraging the model to test different scenarios rather than find a single answer. Based on human feedback, the model can then manipulate the next scenario to get better results.

Sentiment analysis: It is the use of natural language processing, text analysis, computational linguistics, and biometrics to identify, extract, quantify, and study subjective information.

Natural language processing (NLP): The umbrella term for any machine's ability to perform conversational tasks, such as recognizing what is said to it, understanding the intended meaning and responding intelligibly.

2. (a)

Statement 1 is correct: The Department of Science and Technology (DST) implements 'Knowledge Involvement in Research Advancement through Nurturing (KIRAN)' Scheme to provide various career opportunities to women scientists and technologists.

Statement 2 is correct: It is primarily aimed to bring gender parity in the Science & Technology sector byway of inducting more women in the research & development domain.

Statement 3 is not correct: It supports Women in the age group 27 to 57 years by providing fellowship support ranging from Rs. 25000 to 55000 for continuing higher education in Science and Technology after a break in career.

• Orbital debris is any human-made object in orbit about the Earth that no longer serves a useful function. Such debris includes nonfunctional spacecraft, abandoned launch vehicle stages, mission-related debris, and fragmentation debris.

4. (a)

Statement 1 is correct Lunar missions have operated on the time of the country that launched them. But with several lunar explorations heading for the launchpad, the European Space Agency has deemed the current system unsustainable.

Statement 2 is not correct: The International Space Station (ISA) does not have its own time zone. Instead, it runs on Coordinated Universal Time, or UTC, which is based on time kept by atomic clocks. This helps ease the time difference between NASA and the Canadian Space Agency, as well as other space partners in Russia, Japan and Europe.

5. (d)

A small, human-tended **space station orbiting the Moon** that will provide extensive capabilities to support NASA's Artemis campaign.

- Gateway will be humanity's first space station in lunar orbit to support NASA's deep space exploration plans, along with the Space Launch System (SLS) rocket, Orion spacecraft, and the Human Landing System (HLS) that will send astronauts to the Moon. Hence Statement 1 and 3 are correct.
- Gateway's capabilities for supporting sustained exploration and research in deep space include docking ports for a variety of visiting spacecraft, space for crew to live and work, and on-board science investigations to study heliophysics, human health, and life sciences, among other areas.
- Gateway will be a critical platform for developing technology and capabilities to support **Moon and** Mars exploration in the coming years. Hence Statement 2 is correct.
- 6. (a)

Digital India Act, 2023

- Remodelling of the IT Act:
 - The **Digital India Act, 2023** is a broad overhaul of the **Information Technology Act, 2000**.
- Covering new and complex issues:
 - The Digital India Act would cover provisions such as Artificial Intelligence (AI), deepfakes, cybercrime, competition issues among internet platforms, and data protection.
 - The new law would seek to address **"new complex forms of user harms"** that have emerged in the years since the IT Act's enactment, such as **catfishing**, **doxxing**, **trolling**, **and phishing**.
- Reconsideration of the 'safe harbour' provision:
 - The government is reconsidering a key aspect of cyberspace 'safe harbour', which is the principle that 'intermediaries' on the internet are not responsible for what third parties post on their website.
 - This is the principle that allows social media platforms to avoid liability for posts made by users.

7. (d)

Option D is correct: The iCET (Initiative on Critical and Emerging Technologies) is a partnership between **India and the US** to work together in developing important technologies.

• It involves collaboration in a range of areas including quantum computing, semiconductors, 5G and 6G wireless infrastructure, and civilian space projects such as lunar exploration.

8. (a)

Statement 1 is not correct: NCDs, also known as chronic diseases, tend to be of long duration and are the result of a combination of genetic, physiological, environmental and behavioural factors.

Statement 2 is correct: The major NCDs share **four behavioral risk factors-** unhealthy diet, lack of physical activity, and use of tobacco and alcohol. Factors contributing to the rise of NCDs also include ageing, rapid unplanned urbanization and globalization.

Statement 1 is not correct: Venus is Earth's closest planetary neighbour which is similar in structure but slightly smaller than Earth, it is the second planet from the sun. Therefore, Venus has been called Earth's twin. **Venus has an atmosphere 50 times denser than Earth's.** Venus is wrapped in a thick, toxic atmosphere filled with carbon dioxide that traps in heat.

Statement 2 is correct: VERITAS (Venus Emissivity, Radio Science, InSAR, Topography, and Spectroscopy) is an **upcoming mission** from NASA's Jet Propulsion Laboratory (JPL) to map the **surface of planet Venus** in high resolution.

11. (b)

- Pair 1 is not correct: Pfizer and Moderna vaccines developed in the US are mRNA vaccines. mRNAvaccines will carry the molecular instructions to make the protein in the body through a synthetic RNA of the virus.
- Pair 2 is not correct: Johnson & Johnson, Sputnik V and AstraZeneca-Oxford University vaccine is a kind of viral vector vaccine. Such vaccines use a harmless virus to smuggle the instructions for making antigens from the disease-causing virus into cells. By infecting cells and instructing them to make large amounts of antigen, which then trigger an immune response, the vaccine mimics what happens during natural infection
- **Pair 3 is correct:** Bharat Biotech's **Covaxin is an inactivated vaccine.** In this type, an inactivated live virus is used to create an immune response against the disease.
- Pair 4 is correct: Corbevax is a recombinant protein subunit vaccine it is made up of a specific part of SARS-CoV-2 the spike protein on the virus's surface to trigger an immune response.

12. (d)

Statement 1 is correct: e-Kranti is an essential pillar of the Digital India initiative.

- The mission of e-Kranti is to ensure a Government wide transformation by delivering all Government services electronically to the citizens through integrated and interoperable systems via multiple modes while ensuring efficiency, transparency and reliability of such services at affordable costs. Hence, Statement 2 is correct.
- **Statement 3 is correct:** PM SVANIDHI is a Central Sector Scheme by Ministry of Housing and Urban Affairs with the following objectives:

 - (iii) To reward **digital transactions**

Beamforming and Carrier Aggregation are terms associated with telecommunications.

• Beamforming refers to usage of increased number of antennas to aim signals directly toward a specific device, group of devices or location.

• Cellular data is sent using radio frequencies. The wider the channel bandwidth, the more data can be sent. Carrier aggregation combines multiple channels of spectrum together to create one super channel, meaning greater capacity and faster speeds.

14. (b)

Anthrax is a zoonotic disease caused by gram-positive, rod-shaped bacteria known as Bacillus anthracis.

- Hepatitis means inflammation of the liver. It is caused by Hepatitis A virus.
- Leprosy is caused by the bacteria Mycobacterium Leprae.
- **Cryptococcosis** is a disease caused by the yeast-like fungus, Cryptococcosis neoformans. The fungus is found frequently in the environment, particularly in pigeon droppings, nesting places and soil, especially if it is contaminated with pigeon faeces.
- Tuberculosis is caused by bacteria Mycobacterium tuberculosis.
- 15. (c)

Statement 1 is not correct: Mycobacterium tuberculosis, the bacteria that cause tuberculosis (TB) can develop resistance to the antimicrobial drugs used to cure the disease. TB is initially treated with **isoniazid and rifampicin**. If the bacteria develops resistance to them, then **Bedaquiline** is used.

Statement 2 is not correct: National TB Elimination Programme is to meet the goal of ending the TB epidemic by **2025** in India, five years ahead of the Sustainable Development Goals (SDG) for 2030.

In News: A UK-based startup claims to have developed a Biotransformation Technology.

Statement 1 is correct: Biotransformation Technology is a novel approach to ensure plastics that escape refuse streams are processed efficiently and broken down.

Statement 1 is correct: Marburg is a **highly virulent disease** that causes **hemorrhagic fever**, with a fatality ratio of up **to 88%**.

Statement 2 is correct: It is in the same family as the virus that causes Ebola virus disease and they show similar symptoms.

Statement 3 is correct: Severe watery diarrhoea, abdominal pain and cramping, nausea and vomiting can begin on the third day.

• The appearance of patients at this phase has been described as showing "**ghost-like**" drawn features, deep-set eyes, expressionless faces and extreme lethargy.

Statement 1 is correct: OneWeb Constellation is a **satellite-based network** that aims to provide high-speed, low-latency internet connectivity worldwide.

Statement 2 is not correct: It is a collaborative project between the UK-based OneWeb Group and the Indian Space Research Organisation (ISRO), in partnership with NewSpace India Ltd(NSIL).

Statement 3 is not correct: The satellites are placed in low Earth orbit (LEO) and complete a full trip around the Earth in 109 minutes.

Statement 4 is correct: The constellation will **bring secured solutions not only** to enterprises but also to towns, villages, municipalities, and schools, including the **hardest-to-reach areas across India**.

20. (d)

- Hepatitis is caused Infections of the liver from a virus (hepatitis A, hepatitis B, hepatitis C, hepatitis D, and hepatitis E) or a Viral parasite.
- **Jaundice** is a yellow color in the skin, mucous membranes, or eyes. The yellow color comes from bilirubin, a byproduct of old red blood cells. Jaundice is a sign of other diseases, it is often a sign of a problem with the liver, gallbladder, or pancreas.
- Malaria is a life-threatening disease caused by Plasmodium parasites that are transmitted to people through the bites of infected female Anopheles mosquitoes.
- **Tuberculosis (TB)** is caused by a bacterium called Mycobacterium tuberculosis. BCG vaccine protects against tuberculosis. It is provided to children under Mission Indradanush.

21. (d)

- Statement 1 is not correct: The NPPA was set up as an attached office of the Department of Chemicals and Petrochemicals (now Department of Pharmaceuticals since July, 2008) under the Ministry of Chemicals and Fertilizers 1997.
- Statement 2 is not correct: Drugs listed under National List of Essential Medicines (NLEM) known as scheduled drugs are regulated by National Pharmaceutical Pricing Authority (NPPA). It makes changes based on wholesale price index-based inflation.
 - The manufacturer of non-scheduled drugs (drugs not under direct price control) is not required to take price approvals from NPPA for such drugs. However, NPPA is required to monitor the prices of such drugs and take corrective measures where warranted and their includes the power to fix and regulate such prices.

22. (c)

Statement 1 is correct: In the piezoelectric effect, a body develops an electric current when it is squeezed. The piezoelectric effect was **discovered in 1880, in quartz.**

Statement 2 is correct: Quartz is the most famous piezoelectric crystal. Quartz is silicon dioxide (SiO2). The quartz crystal consists of silicon and oxygen atoms at the four vertices of a three-sided pyramid; each oxygen atom is shared by two pyramids. These pyramids repeat themselves to form the crystal.

Statement 3 is not correct: For the first time, scientists have reported evidence of the **piezoelectric effect** in liquids. The reason the piezoelectric effect has only been expected in solids thus far is that the body being squeezed needs to have an organised structure, like the pyramids of quartz. Liquids don't have such structure; instead, they take the shape of their container.

Statement 4 is correct: It is used in this capacity in analog wristwatches and clocks. Such crystals are also used in **cigarette lighters, electric guitars, TV remote controls, audio transducers,** and other instruments where converting mechanical stress to a current is useful.

23. (a)

Statement 1 is correct: Uranium is a chemical element with symbol U and atomic number 92. The most common isotopes in natural uranium are **uranium-238** (which has 146 neutrons and accounts for over 99% of uranium on Earth) and **uranium-235** (which has 143 neutrons).

Statement 2 is not correct: Uranium-235 is the **only naturally occurring** fissile isotope, which makes it widely used in nuclear power plants and nuclear weapons.

24. (c)

Statement 1 is correct: Rare diseases (also called "Orphan" diseases) are broadly defined as diseases that infrequently occur in a population. Examples: Lysosomal Storage Disorders (LSD), Pompe disease, cystic fibrosis, muscular dystrophy, spina bifida, haemophilia etc.

Haemophilia is usually an inherited bleeding disorder in which the blood does not clot properly. This can lead to spontaneous bleeding as well as bleeding following injuries or surgery. Blood contains many proteins called clotting factors that can help to stop bleeding.

1. (b)

Statement 1 is not correct: Seahorses are a type of marine fish that are named for their distinctive head and neck, which resemble those of horses. Generally, found in **shallow tropical and temperate waters** throughout the world.

Statement 2 is not correct: Seahorses are **poor swimmers** but migrate by rafting clinging to floating substrata such as macroalgae or plastic debris for dispersal by ocean currents – to new habitats for successful maintenance of their population.

Statement 3 is correct: They are declining due to the overexploitation for traditional Chinese medicines and as ornamental fish.

2. (b)

Option B is correct: Tetracycline, glycopeptides, and chloramphenicol are an antibiotic used to treat certain **bacterial infections** when these are released into the soil through dung and urine, they alter the microbial communities in soil in ways that are detrimental for sequestering carbon resulting in lower carbon storage in soil.
