**Mugger crocodile** (Crocodylus palustris), also called marsh crocodile or broad-snouted crocodile. It is native to freshwater habitats from southern Iran and Pakistan to the Indian subcontinent and Sri Lanka. The mugger has been listed as **vulnerable** on the IUCN Red List since 1982.

**Saltwater crocodile**(Crocodylus porosus) is the earth's largest living crocodilian, with average-size males reaching 17 feet and 1,000 pounds. IUCN Red List: **Least Concern** 

3. (d)

**[SOL]** The UN Security Council, under India's presidency, adopted a resolution (**Resolution 2593**) demanding that the territory of Afghanistan should not be used to threaten any country or shelter terrorists.

#### 5. **(b)**

- **Birds are the natural hosts** of the West Nile virus.
- Human infection is most often the result of bites from infected mosquitoes. Mosquitoes
  become infected when they feed on infected birds, which circulate the virus in their blood
  for a few days.
  - o **No human-to-human transmission** of WNV through casual contact has been documented.

**Statement 3 is not correct:** It is **commonly found** in Africa, Europe, the Middle East, North America and West Asia.

#### **6.** (d)

[SOL] Statement 1 is not correct: Atal Pension Yojana (APY) was launched in 2015 with the objective of delivering old age income security particularly to the workers in the unorganised sector and the Government providing a guarantee of minimum pension after 60 years of age. It is administered by the Pension Fund Regulatory and Development Authority (PFRDA).

**Statement 1 is not correct**: Scrub typhus, also known as bush typhus, is a disease caused by a **bacteria** called Orientia tsutsugamushi. It is spread to people through bites of infected chiggers (larval mites).

**Statement 2 is not correct:** Apart from **India**, cases of scrub typhus have been reported from rural areas of **Indonesia**, **China**, **Japan and northern Australia**.

**Statement 3 is correct: No vaccine is available** to **prevent scrub typhus**. It suggested the risk of contracting the infection by avoiding contact with infected chiggers.

- When travelling to regions where scrub typhus is common, people should avoid areas with lots of vegetation and brush where chiggers may be found.
- If someone gets infected by scrub typhus then it should be **treated with the antibiotic doxycycline**.

#### 8. (b)

**[SOL]** Irrawaddy dolphins are found in coastal areas in South and Southeast Asia, and in three rivers: the Ayeyarwady (Myanmar), the Mahakam (Indonesian Borneo) and the Mekong. Irrawaddy dolphins fall under Schedule I of the Indian Wildlife (Protection) Act, 1972 and are mentioned in the International Union for the Conservation of Nature (IUCN) Red List of **Endangered Species**.



#### 9. (c)

- o Consumers should insist on getting all the information about the product or service before making a choice or a decision. This will enable him to act wisely and responsibly and also enable him to desist from falling prey to high pressure selling techniques.

#### Right to Choose

Means right to be assured, wherever possible of access to a variety of goods and services at competitive price. In case of monopolies, it means the right to be assured of satisfactory quality and service at a fair price. It also includes the right to basic goods and services. This is because the unrestricted right of the minority to choose can mean a denial for the majority of its fair share. This right can be better exercised in a competitive market where a variety of goods are available at competitive prices

#### Right to be Heard

- o Means that consumer's interests will receive due consideration at appropriate forums. It also includes the right to be represented in various forums formed to consider the consumer's welfare.
- o The Consumers should form non-political and non-commercial consumer organizations which can be given representation in various committees formed by the Government and other bodies in matters relating to consumers.

#### Right to Seek redressal

- o Means right to seek redressal against unfair trade practices or unscrupulous exploitation of consumers. It also includes the right to fair settlement of the genuine grievances of the consumer.
- Oconsumers must make complaints for their genuine grievances. Many times their complaint may be of small value but its impact on the society as a whole may be very large. They can also take the help of consumer organisations in seeking redressal of their grievances.



## Right to Consumer Education

Means the right to acquire the knowledge and skill to be an informed consumer throughout life. Ignorance of consumers, particularly of rural consumers, is mainly responsible for their exploitation. They should know their rights and must exercise them. Only then real consumer protection can be achieved with success.

# 11. (d)

[SOL] In News: The International Monetary Fund (IMF) has sharply increased its allocation of Special Drawing Rights (SDR) to India, in line with the country's existing quota in the fund. Special Drawing Right (SDR) is a kind of reserve of foreign exchange assets comprising leading currencies globally and created by the International Monetary Fund in the year 1969. SDR is often regarded as a 'basket of national currencies' comprising major currencies of the world - US dollar, Euro, British pound sterling, Yen (Japan) & the Chinese renminbi (included in 2016).

- The composition of this basket of currencies is reviewed every five years wherein the weightage of currencies sometimes get altered.
- SDR can be freely exchanged between the member countries instead of relying on the currency of any one particular country.

## 12. (c)

**[SOL] In News:** Recently, Indian researchers found that half of the blue stragglers in their sample are formed through mass transfer from a close binary companion star.

- Blue stragglers are a class of **stars on open or globular clusters** that stand out as **they are bigger and bluer** than the **rest of the stars**.
  - o They have intrigued scientists who have for long probed their origin.
- It is found in **old star clusters and appears** to be **lagging behind most of the other stars** in the cluster in its evolution toward a cooler, reddish state.
  - o Blue stragglers tend to be strongly concentrated toward the centre of the cluster.

# 13. (a)

[SOL] Dara Shikoh was born in Ajmer, the land of Khwaja Moinuddin Chishti, to whom his father Shah Jahan had prayed for a son. Dara Shikoh, who was Mughal emperor Shah Jahan's son and expected heir, was killed on the orders of his brother Aurangzeb in 1659 after losing the war of succession. At the age of twenty-five, Dara wrote his first book, Safinat-ul-Awliya, a concise document detailing the lives of the Prophet and his family, the Caliphs and of saints belonging to the five major Sufi orders then popular in India. Dara Shikoh is described as a "liberal Muslim" who tried to find commonalities between Hindu and Islamic traditions.

- He had a deep understanding and knowledge of major religions, particularly Islam and Hinduism is known as a pioneer of the academic movement for interfaith understanding in India.
- He strove to develop cordial relationships between people by finding commonalities between Hinduism and Islam and bringing their cultures into dialogue.
- His most important works, **Majma-ul-Bahrain** (Mingling of Two Oceans) and **Sirr-i-Akbar** (Great Mystery) are devoted to the cause of establishing connections between Hinduism and Islam.
- He not only discovered commonalities but even said that the foundation of the two religions is the same, which is the belief, "One Reality and One God". He had a pluralistic outlook and understood India's syncretic culture.



- Dara Shikoh acquired proficiency in Sanskrit and Persian, which enabled him to play a
  key role in popularising Indian culture and Hindu religious thought. He translated the
  Upanishads and other important sources of Hindu religion and spirituality from Sanskrit to
  Persian.
- Dara Shikoh had a keen interest in the fine arts and architecture. An album he dedicated to his wife is a treasure of Indian art.
- A rare miniature painting showing him with his spiritual masters is preserved in the library of the Aligarh Muslim University (AMU). As a talented architect, he designed the **beautiful Pari Mahal Garden Palace** in Srinagar and many other monuments. the 'Iksir-i-Azam'.
- He also commissioned the 'Jug Bashist' and the 'Tarjuma-i-Akwal-i-Wasili'.

#### 14. (b)

  - ☐ A constellation of earth and space-weather observation satellites is envisaged under the INSPIRE programme.


The INSPIRESat-1 mission was **originally planned for 2020** but was delayed due to the COVID-19 pandemic.

- The small satellite that weighs less than 10 kg will be launched aboard an upcoming Polar Satellite Launch Vehicle (PSLV) mission of the Indian Space Research Organisation (ISRO).
- It is equipped with a Compact Ionosphere Probe for studying the earth's ionosphere.
- It has been fully integrated, tested and will be placed in a low earth orbit.
  - o A **low Earth orbit (LEO)** is an orbit around Earth with an altitude above Earth's surface from **160 km to 2,000 kilometres**.

#### 24. (a)

[SOL] Durand Line is the **2,670-kilometre-long** international land border between **Afghanistan** and **Pakistan**.

- Presumably, the first incidence of Nipah virus infection occurred when pigs in Malaysian farms came in contact with the bats who had lost their habitats due to deforestation.
  - Nipah virus was first recognized in 1999 during an outbreak among pig farmers in, Malaysia.
  - O The infection is also known to affect human beings.
- The organism which causes Nipah Virus encephalitis is an RNA or Ribonucleic acid virus
  of the family Paramyxoviridae, genus Henipavirus, and is closely related to Hendra virus.

Statements 3 and 4 are correct: The case fatality rate is estimated at 40% to 75%. This rate can vary by outbreak depending on local capabilities for epidemiological surveillance and clinical management.

- The virus can also **cause severe disease in animals** such as pigs, resulting in significant economic losses for farmers.
- There are currently no drugs or vaccines specific for Nipah virus infection although WHO has identified Nipah as a priority disease for the WHO Research and Development Blueprint.
- Intensive supportive care is recommended to treat severe respiratory and neurologic complications.

- The first **16 of these aircraft** will be delivered in **flyaway condition from Spain**, within **48 months of the contract** being signed, the remaining 40 will be manufactured in India by a consortium led by the Tata Group over 10 years.
- This is the first project of its kind in which a military aircraft will be manufactured in India by a private company.
  - o All fifty-six aircraft will be installed with the indigenous Electronic Warfare Suite.

# **39.** (c)

**[SOL] In News:** Public Sector banks are experiencing a sharp surge in the proportion of Mudra loans turning into non-performing assets (NPAs).

• The prime reason behind such a trend is the impact of Covid on incomes and repayment capacity of borrowers.

# **Statement 1 is not correct.** There are **three categories**:

- o Shishu loan up to Rs 50,000
  - for micro entrepreneurs like vendors and shopkeepers,
- o Kishor loan of Rs 50,000-Rs 5 lakh
  - ☐ for smaller enterprises like buying for light commercial vehicles, allied agriculture activities and equipments, and
- o Tarun loan accounts of Rs 5-10 lakh
  - ☐ for, say, food product units.

**Statement 2 is correct.** Out of total Mudra loans of Rs 11,357.14 crore, Rs 1,055.53 crore or 9.29 per cent have turned into NPAs as on June-end 2021.

**Statement 3 is correct.** The Credit Guarantee Fund for Micro Units (CGFMU) set up by the Central Government provides lenders guarantee against loan losses in Mudra loans.

- But the extent of the spike in NPAs is higher than the cover being provided.
- In April, 2020, the Government had increased the guarantee to 75 percent of NPAs in Mudra loans, from 50 per cent earlier.
  - o But the cap on guarantee payout has been kept at 15 percent of total loans.

## **40.** (d)

**[SOL] Statement 1 is not correct: Equal protection of Law** connotes equal treatment under equal circumstances both in privileges and liabilities.

**Statement 2 is not correct: Equality before Law** connotes absence of any special privileges in favor of any person.



**[SOL] In News:** A leopard at the Asola Bhatti Wildlife Sanctuary has been caught on a camera trap – the first piece of concrete evidence of the recent presence of the big cat in the area.

- It is located on Southern Ridge, the northern terminal of Aravalli Hills, one of the oldest mountain systems in the world.
- It is located in South Delhi Distt. All along with Delhi, Haryana, Faridabad & Gurgaon.

## 42. (a)

**[SOL] In News:** The first deliverable Firing Unit (FU) of **Medium Range Surface to Air Missile (MRSAM) System** was handed over to the Indian Air Force (IAF) to boost India's defence capabilities.

**Statement 1 is correct:** The MRSAM (IAF) is an **advanced network-centric combat Air Defence System.** It is capable of engaging multiple targets at ranges up to 70 km in severe saturation scenarios.

o The missile is powered by an indigenously developed rocket motor and control system for achieving high manoeuvrability during the terminal phase.

Statement 2 is not correct: It is developed jointly by the Defence Research and Development Organisation (DRDO) and Israel Aerospace Industries (IAI) in collaboration with the Indian industry comprising private and public sectors including MSMEs.

• It **provides point and area air defenc**e for ground assets against a wide range of threats including fighter aircraft, UAVs, helicopters, guided and unguided munitions, sub-sonic & supersonic cruise missiles etc.

### 43. (d)

**[SOL]** The National Institutional Ranking Framework (NIRF) has been accepted by the Ministry for Education (MoE) and launched on 29th September 2015. This framework outlines a methodology to rank institutions across the country. Parameters used for ranking institutions in NIRF are:

- Teaching, Learning and Resources
- Research and Professional Practices
- Graduation Outcomes
- Outreach and Inclusivity.
- · Peer Perception.

## **44.** (d)

[SOL] In News: The Centre has increased the minimum support price (MSP) for wheat for the upcoming rabi season to ₹2,015 per quintal, a 2% hike from last year.

• Oilseeds and pulses such as mustard, safflower and masoor dal saw higher MSP increases of up to 8% in a bid to encourage crop diversification. (Hence, Statement 2 is not correct. The disproportionate rise is in Oilseeds and Pulses not in Rice.)

**Statement 1 is not correct.** The Commission for Agricultural Costs & Prices (CACP) **recommends (not declares)** MSPs for all crops based on different factors.

• The **Cabinet Committee on Economic Affairs (CCEA)** takes a final decision on the level of MSPs and other recommendations made by CACP.



## 45. (a)

**[SOL] In News**: Lingayats, a dominant community (nearly 17% of Karnataka's six crore population), are demanding reservation under OBC quota.

**Option D is correct:** The Lingayat/Veerashaiva community, a politically dominant group in Karnataka, are devotees of Shiva. The Lingayats follow 12th-century saint-philosopher Basavanna who had rejected ritualistic worship and pre-eminence of the Vedas. They have the wide following in the Southern part of India. Lingayats constitute 17% of the total population in Karnataka.

## **46.** (c)

[SOL] In News: Niranjanpur wetland in Dehradun (Uttarakhand) has lost most of its fishes

- Niranjanpur wetland lies in a coveted real estate area of Dehradun city.
- It is home to flocks of birds, insects, tadpoles, small fishes and mammals.
- It attracts tiny local birds to big migratory birds in winters.
- Common moorhen (jal murgi) swims in its water-pools, while the black kite preys across its waters.
- It also helps in groundwater recharge.

## 47. (d)

[SOL] The central government notifies the status of minorities to a religion in India.

- Constitution has not defined the term minority neither laid down procedures to notify a community or religion as a minority community.
- Muslims, Sikhs, Christians, Buddhists, Jain and Zoroastrians (Parsis) have been notified as minority communities under Section 2 (c) of the National Commission for Minorities Act, 1992. As per the Census 2011, the percentage of minorities in the country is about 19.3% of the total population of the country. The population of Muslims are 14.2%; Christians 2.3%; Sikhs 1.7%, Buddhists 0.7%, Jain 0.4% and Parsis 0.006%

#### **48.** (c)

**[SOL] In News:** The index of industrial production (IIP) grew 11.5% in July, driven by a contracted base.

**Statement 1 is correct:** The Index of Industrial Production (IIP) is a **composite indicator** that measures the **short-term changes** in the **volume of production** of a basket of industrial products during a given period with **respect to that in a chosen base period.** 

**Statement 2 and 3 are not correct:** In India, the first official attempt to compute the **Index of Industrial Production** (IIP) was made much earlier than the first recommendation on the subject came at the international level.

- With the inception of the Central Statistical Organization (now known as the National Statistics Office (NSO)) in 1951, the responsibility for compilation and publication of IIP was vested with it.
- IIP index is currently calculated using 2011-2012 as the base year.

## **49.** (c)

[SOL] Rice kernels can be fortified with several micronutrients, such as iron, folic acid and other B-complex vitamins, vitamin A and zinc. The addition of basic material like **ferric pyrophosphate** and enhancing compounds like **citric acid** and **trisodium citrate** mixtures to increase iron absorption in a staple food is the most common form of fortification. Iodine is used in salt fortification.



**[SOL] Statement 1 is correct:** Minority Stake Sale happens when the Government intends to sell a part of the PSU from its overall shareholding, given that post stake sale the GOI ownership is still above 51%.

**Statement 2 is correct:** Asset Monetization involves the creation of new sources of revenue by unlocking the value of hitherto unutilized or underutilized public assets.

## 51. (a)

[SOL] Vinoba Bhave, byname of Vinayak Narahari Bhave was Born in 1895 in a high-caste Brahman family.

- He abandoned his high school studies in 1916 to join Gandhi's ashram (ascetic community) at Sabarmati, near Ahmedabad.
  - o Gandhi's teachings led Bhave to a life of austerity dedicated to improving Indian village life.
- He was one of India's best-known social reformers and a widely venerated disciple of **Mohandas K.** (Mahatma) Gandhi.
- He was given the honorific title acharya ("teacher"). His writings and teachings revolutionised Sarvodaya social order, one that emphasised the importance of non-violence, goodwill and equality in society.
- He was the founder of the **Bhoodan Movement("Land-Gift Movement").** 
  - o He dedicated his life to propagating Gandhian values and is particularly known for "**Bhoodan'**"
- His mass movements were aimed at ensuring a better quality of life for the poor and downtrodden.

# **52.** (b)

**[SOL] In News:** A bilateral meeting was held between India and Germany in New Delhi to discuss a wide range of environmental issues.

• The discussion covered areas such as climate change, water scarcity, marine & air pollution, circular economy, etc.

**Statement 1 is correct.** Both India and Europe are facing heatwaves and floods due to climate change, although the nature and extent are highly different for both.

#### **53. (b)**

[SOL] Subramania Bharati was an outstanding Indian writer of the nationalist period and is regarded as the father of the modern Tamil style. He is also known as 'Mahakavi Bharathiyar'.In his early life, he worked in various capacities like sub-editor of Swadesamitran, a Tamil daily and Chakravartini, a Tamil monthly. His English works were collected in Agni. He got involved in the extremist wing of the Indian National Congress (INC) party. He attended the annual sessions of INC and discussed national issues with extremist leaders like Bipin Chandra Pal, B.G. Tilak and V.V.S. Iyer.

His vision of nationalism was secular, against casteism and sexism, and pan-Indian.

He wrote many patriotic poems which received praise for their nationalistic themes.

In 1908 he was forced to flee to Pondicherry, where he lived until 1918. After his return, he rejoined the Tamil daily Swadesamitran.

Role as a social reformer:

He was vocal against the caste system and consistently spoke about women's issues.



He was influenced by Sister Nivedita, a disciple of Vivekananda.

He spoke out against social issues such as child marriage, untouchability through his writings.

He was a prolific writer and poet and fluent in Tamil, Hindi, Sanskrit, English and French.

He brought a renaissance in Tamil literature. Some of his famous works are:

- Panchali sapatham (1912)
- Kuyil pāṭṭu (1912)
- Kaṇṇan pāṭṭu (1917)

He wrote poems concerning issues from all around the world.

His English works were collected in Agni.

# 54. (c)

[SOL] Bass Strait is a strait separating the island of Tasmania from the Australian mainland. It provides the most direct waterway between the Great Australian Bight and the Tasman Sea.

#### 55. (b)

**[SOL] Statement 1 is not correct:** Their **scientific name** is **Lepidochelys olivacea** and they are also known as the **Pacific ridley sea turtle.** They are the **smallest** and **most abundant** of all sea turtles found in the world. They are found in warm waters of the Pacific, Atlantic and Indian oceans. They are vulnerable according to the IUCN Red List.

**Statement 2 is not correct:** They are not herbivores, these are carnivores and feed mainly on jellyfish, shrimp, snails, crabs etc.

**Statement 3 is correct**: These are best known for their unique mass nesting called Arribada, where thousands of females come together on the same beach to lay eggs. One unique feature about females is that they return to the very same beach from where they first hatched, to lay their eggs. The eggs **hatch** in **45 to 60 days**, depending on the temperature of the sand and atmosphere during the incubation period.

Statement 2 is not correct. The EU Green Deal has set the target of Net (not Gross) Zero Emissions by 2050 (Not 2070).

**Statement 3 is correct.** Germany is India's largest trading partner in Europe.

## **56.** (d)

[SOL] Statement 1 is not correct: Each State has a Council of Ministers to aid and advise the Governor in the exercise of his functions. The Chief Minister is the head of the government in the State. The Council of Ministers with the Chief Minister as its head exercises real authority at the State level. Under Article 164, the Chief Minister is appointed by the Governor. The other Ministers are appointed by the Governor on the advice of the Chief Minister. The ministers included in the Council of Minister's must belong to either House of the State legislature.

 A person who is not a member of the State legislature may be appointed a minister, but he/she ceases to hold office if he/she is not elected to the State legislature within six months of his appointment.

**Statement 2 is correct:** CM and other Ministers shall hold office during the pleasure of the Governor. CM cannot be dismissed by the governor as long as he enjoys the majority support in the legislative assembly. The State Legislative Assembly can also remove him by passing a vote of no-confidence against him. The Chief Minister is the head of the Council of Ministers of his State. The constitutional position of the Chief Minister is more or less similar to that of the Prime Minister. The Chief Minister plays an important role in the administration of the State. The major functions include:



The Governor allocates portfolios to the ministers on the advice of the Chief Minister.

The Chief Minister presides over the Cabinet meetings. He/she coordinates the functioning of different ministries. He/she guides the functioning of the Cabinet.

The Chief Minister plays a key role in framing the laws and policies of the State Government. Under Article 167, the Chief Minister is the sole link of communication between the Cabinet and the Governor.

The Governor has the right to be informed by the Chief Minister about the decisions taken by the Council of Ministers.

**Statement 3 is not correct:** The Chief Ministers of the States included in each zone act as **Vice-Chairman of the Zonal Council** for that zone by rotation, each holding office for a period of one year at a time.

## **57. (b)**

**[SOL] Statements 1 is not correct::** It was enacted by the Parliament and approved by the President in 1958.

- It confers certain **special powers on members of the Armed Forces** (military forces, air forces operating on the ground as land forces and any other armed forces of the Union (CRPF, BSF, ITBP etc) for carrying out **proactive operations against the insurgents in a highly hostile environment.** 
  - o They have the authority to prohibit a **gathering of five or more persons** in an area.
- The AFSPA is also in force in the entire Nagaland, certain districts of Arunachal Pradesh, and most parts of Manipur barring the Imphal municipal areas.
- Under Section 3 The Central Government or the Governor of the State or administrator of the Union Territory can declare the whole or part of the State or Union Territory as a disturbed area.
  - o An area can be disturbed due to **differences or disputes between members** of **different religious**, racial, language or regional groups or castes or communities.

Statement 2 is correct: Section 4 gives the Army powers to search premises and make arrests without warrants, to use force even to the extent of causing death, destroy arms/ammunition dumps, fortifications/shelters/hideouts and to stop, search and seize any vehicle.

- Section 6 stipulates that arrested persons and the seized property are to be made over to the police with the least possible delay.
- Section 7 offers protection of persons acting in good faith in their official capacity.
  - o The prosecution is permitted only after the sanction of the Central Government.

# **58.** (d)

**[SOL] Statements 1, 2 and 3 are correct:** It is located in Pilibhit district, Lakhimpur Kheri District and Bahraich District of Uttar Pradesh.

- o It is situated in the **Terai region of northern India**.
- o While the northern area of the reserve touches the Indo-Nepal border, the southern edge is connected to **Khakhra and Sharda rivers**.
- o It is a **mosaic of high sal and teak forests**, plantation, grasslands and swamps maintained by periodic flooding from rivers.
- o The major forest types found here include dry deciduous forests, open woodlands, grasslands and riverine covered with thorny woodlands and tall grass.



- It was declared a **tiger reserve** in 2008.
  - o It won the **TX2 award** for doubling the tiger population in just four years from 2014 when it had 25 tigers which went up to 65 in 2018.
- It represents the **only tiger population** with the ecological and behavioural adaptations of the tiger unique to the Terai region.
  - o It is home to habitat for over 127 animals, 326 bird species and 2,100 flowering plants.
  - **o** Several endangered species like the pangolin, Bengal Florican, vulture, sloth deer etc are found here.

**[SOL] In News:** The Government has approved the Production Linked Incentive (PLI) Scheme for Textiles with a budgetary outlay of Rs. 10,683 crore.

- The scheme has been designed with a view to providing a big fillip to the man made fibres and technical textiles segments of the industry.
- With this, India is poised to regain its dominance in Global Textiles Trade

**Statement 1 is correct.** Indian exports in the textile sector have almost stagnated over the past seven years.

• India is ranked sixth in the global trade in this sector.

**Statement 2 is not correct.** The scheme will not impact traditional textile segments such as jute or cotton. It aims only at Technical fibres and Man Made Fibres.

**Statement 3 is correct.** One of the criticisms of the scheme is limited target beneficiary manufacturers due to minimum investment thresholds and select product lines.

#### **60. (b)**

[SOL] In News: According to an internal RBI notice, 10 foreign NGOs had been placed in the Prior Reference Category (PRC) of the Foreign Contribution Regulation Act (FCRA), 2010.

• Recently, the government has made both banks and chartered accountants accountable for any unauthorised funds that come through.

**Statement 1 is not Correct.** The NGOs under Prior Reference Category have to take clearance from the MHA's Foreigners Division of the FCRA wing.

**Statement 2 is Correct.** It has been criticised for being over regulatory and has led to closure of multiple NGOs in India.

- Among those who have been put on the PRC list or had to downsize or even shut down their Indian operations due to FCRA action by the government in the last few years are
  - o Greenpeace International,
  - o Amnesty International,
  - o Human Rights Watch,
  - o Compassion International,
  - o National Endowment for Democracy,
  - o U.S. Centre for Disease Control (CDC),
  - o Open Society Foundation.



[SOL] Swami Vivekananda was born on 12<sup>th</sup> January 1863 in a Bengali family in Calcutta and was originally named Narendranath Datta.

- In 1893, he took the name 'Vivekananda' after Maharaja Ajit Singh of the Khetri State requested him to do so, changing from 'Sachidananda' that he used before. He was one of India's greatest spiritual leaders and inspired the youth of India to become better, leading a life of purity and setting an example for the world.
  - o Netaji Subhas Chandra Bose had called him the "Maker of Modern India".
- He played an important role in **introducing the philosophies of Yoga and Vedanta to the West**. He preached '**neo-Vedanta**', an interpretation of Hinduism through a Western lens and believed in combining spirituality with material progress. In his honour, the Government of India in **1984** declared his birthday **National Youth Day**.
- He is best known for his speech at the Parliament of the World's Religions in Chicago in 1893.
  - o He started the speech with the opening remarks, "My brothers and sisters of America" and covered topics including universal acceptance, tolerance and religion.
  - o He began delivering lectures at various places in the US and UK and became popular as the 'Messenger of Indian Wisdom to the Western World'.

## **62. (b)**

[SOL] Statement 1 is not correct: The project was initially proposed in 2009 after the Mumbai terrorist attack with a budget of ₹2,800 crores.

o The 26/11 terrorist siege in Mumbai back in 2008 exposed the deficiency that security agencies had no mechanism to look for vital information on a real-time basis.

**Statement 2 is correct:** It is conceptualised as a **seamless and secure database** for information on terrorists, economic crimes and similar incidents to help bolster India's capabilities. It has been envisaged as a robust mechanism to track suspects and prevent terrorist attacks with real-time data and access to classified information like immigration, banking, individual taxpayers, air and train travel.

Statement 3 is correct: It is an online database for collating scattered pieces of information and putting them together on one platform.

- o It links **intelligence and investigation** agencies and is exempted from the Right to Information Act, 2005 under sub-section (2) of Section 24.
- o It will utilise technologies like **Big Data and data analytics** to study and **analyse the huge amounts** of **data from various intelligence** and enforcement agencies to help track suspects in various cases as required.
- o It is intending to set up an Entity Extraction, Visualization, and Analytics (EVA) system.
- It is mandated with a **counter-terrorism measure** that collects and collates a host of information from government databases including tax and bank account details, credit card transactions, visa and immigration records, itineraries of Rail and air travel etc.

## 63. (a)

**[SOL] Option A is correct:** The BRIC group was renamed as BRICS (Brazil, Russia, India, China, South Africa) after South Africa was accepted as a full member at the BRIC Foreign Ministers' meeting in New York in 2010.



- BRICS consists of the major emerging economies from the world, comprising **41% of the world** population.
- It contributes 24% of the world GDP.
- It has 16% share in world trade.
- Total combined area of 29.3% of the total land surface of the world.

## **64. (b)**

### [SOL] In News:

- The Ministry of Agriculture and Farmers welfare has signed 5 MOUs with private companies for **taking forward Digital Agriculture**.
  - o MOUs were signed for pilot projects with CISCO, Ninjacart, Jio Platforms Limited, ITC Limited and NCDEX e-Markets Limited (NeML).
  - o MOUs aimed at increasing farmers' income and protecting their produce.

Statement 1 is correct. A Digital agriculture mission has been initiated for 2021 -2025 by the government for projects based on new technologies.

o The new technologies which will be harnessed are AI, block chain, remote sensing and GIS technology, use of drones and robots etc.

**Statement 2 is correct.** Recognizing the importance of Digitization in Agriculture the Department is creating a **federated Farmers Database.** 

- Different Services will be built around this Database so as to develop an organic **Digital Ecosystems of Agriculture**.
- Federated farmers' databases will be linked by the land records of farmers from across the country.
  - o It will create a unique Farmer ID.

**Statement 3 is not correct.** It involves **public and private players** in agricultural inputs and services and also logistics.

# **65. (b)**

**[SOL] Statement 1 is correct.** QUAD is an **informal** strategic forum of four nations named India, Japan, US and Australia.

**Statement 2 is not correct.** The idea of Quad was first mooted by the **Japanese Prime Minister** in 2007.

**Statement 3 is not correct.** Malabar Exercise, initiated by **India and US in 1992,** now includes all QUAD members as participants. Japan joined in 2015.

## 66. (d)

**[SOL] Statement 1 is not correct:** Connect Karo 2021 event is being organized by the **World Resources Institute (WRI)** through video conferencing.

**Statements 2 and 3 are correct:** It brings together Indian, global leaders, policymakers and other stakeholders committed to **designing inclusive**, **sustainable and climate f**orward Indian cities.

- It is held every year and it sees presenters from various fields air pollution, electric mobility, urban planning, urban water resilience, climate mitigation, and public transit among others sharing their insights and research findings.
- Theme: 'Clean, Green & Just'.
- It will be on addressing critical challenges faced by Indian cities with an emphasis on deep dive cities of Mumbai, Delhi, Kochi, Hyderabad and Bengaluru.



[SOL] Statement 1 is not correct: The Groundswell report is released by the World Bank.

• The Groundswell report is a stark reminder of the human toll of climate change, particularly on the world's poorest who are contributing the least to its causes.

**Statement 2 is correct:** It clearly lays out a **path for countries to address** some of the key factors that are causing climate-driven migration.

- The updated report includes projections and analysis for three regions: **East Asia and the Pacific, North Africa, and Eastern Europe** and Central Asia.
- It builds on the novel and pioneering modelling approach of the previous World Bank Groundswell report from 2018, which covered **Sub-Saharan Africa**, **South Asia**, and **Latin America**.

Statement 3 is not correct: Sub-Saharan Africa will have the largest number of internal climate refugees by 2050.

- o By 2050, sub-Saharan Africa could see as many as 86 million internal climate migrants
  - ☐ East Asia and the Pacific, 49 million
  - □ South Asia, 40 million
  - □ North Africa, 19 million
  - □ Latin America, 17 million
  - Eastern Europe and Central Asia, five million.

#### **68.** (a)

[SOL] In News: World Ozone Day is observed on the 16th of September every year.

**Option A is correct:** The Montreal Protocol was **framed at the Vienna Convention** with an aim to reduce usage of substances that deplete the ozone layer.

- The Montreal Protocol is the only UN treaty which has been ratified by 197 members of the United nations (UN).
- The **Kigali Agreement** was also signed to support the Montreal protocol.
- Kigali Agreement: signed in 2019, the Kigali Agreement works with an objective to reduce the usage of hydro-fluorocarbons by 80% to 85% by 2040, in order to reduce the greenhouse gases.

#### 69. (d)

## [SOL] In News

- As per a study by Bihar Pollution Control Board, the arsenic contamination has found its way into the food chain- mainly rice, wheat and potato.
- Arsenic contamination in groundwater has been a growing concern in several parts of the country.

**Statement 1 is not correct.** Arsenic pollution causes Skin Cancer and Black Foot Disease. (Fluoride causes mottling of teeth and spinal cord deformation.)

**Statement 2 is not correct.** The permissible limit set by the Indian government for Arsenic in absence of alternate water source is **50 microgram per liter**.

**Statement 3 is not correct.** MuktoShri rice is an Arsenic resistant rice variety.



**[SOL] In News:** The NITI Aayog in collaboration with RMI and RMI India launched the 'Shoonya' programme.

**Option C is correct:** It is an initiative to **promote zero-pollution delivery vehicles** by working with consumers and the industry.

- As part of the campaign, a corporate branding and certification programme is being launched to recognise and promote the industry's efforts towards transitioning to EVs for final-mile deliveries.
- It aims to accelerate the **adoption of electric vehicles** (EVs) in the urban deliveries segment and create consumer awareness about the benefits of zero-pollution delivery.

#### 71. (a)

**[SOL] Statement 1 is not correct:** It was set up in 1986 to function as a repository of information on crime and criminals.

- It was established on the recommendations of the **Tandon Committee** to the National Police Commission (1977-1981) and the MHA's Taskforce (1985).
- NCRB was entrusted with the responsibility for monitoring, coordinating and implementing the Crime and Criminal Tracking Network & Systems (CCTNS) project in the year 2009.

**Statement 2 is not correct:** In August 2017, NCRB launched the National Digital Police Portal, which allows search for a criminal/suspect on the CCTNS database.

- They are spread through states of **Tamil Nadu**, **Kerala**, **Karnataka**, **Goa**, **Maharashtra** and **Gujarat**.
- The Ghats are often called the Great Escarpment of India and are also a UNESCO World Heritage Site.
- The Western Ghats are internationally recognized as a region of immense global importance for the conservation of biological diversity, besides containing areas of high geological, cultural and aesthetic values.



- The Persian Gulf, a mediterranean sea, is part of the Indian Ocean. It is located in Western Asia.
- The water body is bounded by several countries, including Iran to the north, Qatar, Saudi Arabia, and the United Arab Emirates on the peninsula, and Bahrain, Iraq, and Kuwait in the northwest
- It has a coastline length of about 5,117 km, with Iran having the longest coastline (1,536 km).
- It is an extension of the **Gulf of Oman** and connects to the Indian Ocean via the **Strait of Hormuz** in the east.
- The Persian Gulf lies between the Arabian Peninsula and Iran to the southwest and northeast respectively.

#### 111. (d)

**[SOL] Pandit Deendayal Upadhyaya was** Born on September 25, 1916, in the sacred region of Brij in the village of Nagla Chandrabhan in Mathura District.

- o He lost his parents at an early age and was brought up by his maternal uncle.
- o He attended high school in Sikar. Being regarded as a brilliant student, the **Maharaja** of **Sikar gave** him a gold medal, ₹250 for books and a monthly scholarship of ₹10.
  - He joined RSS in 1937 and came under the influence of Shri Nana ji Deshmukh and Shri Bhau Jugade. He launched the weekly 'Panchjanya' and the daily 'Swadesh'.
- o He was a creative writer and a renowned editor. He was a journalist in 'Rashtra Dharma' daily, worked as an editor for 'Panchjanya' and wrote a column named 'Political Diary' for the weekly 'the Organiser'.
- o His mantra for journalism was 'Don't distort the news'. He wrote a number of books including Samrat Chandragupt, Jagatguru Shankaracharya, Political Diary, Integral humanism, Ekatmamanav vad and an analysis of the Five Year plans in India.
- o He convened on September 21, 1951, a political convention of UP and founded the state unit of the new party, Bharatiya Jana Sangh.
- o He was the leader of the Bharatiya Jana Sangh from 1953 to 1968.



**[SOL] Statements 1, 2 and 3 are not correct:** The study 'Clinicopathological Profile of Cancers in India was released by the Indian Council of Medical Research (ICMR). Out of the 6,10,084 cancers, 3,19,098 (52.4%) cancers were reported in males, and 2,90,986 (47.6%) in females.

- The proportion of all cancer cases was higher in males than females with gynaecological cancers, including breast cancer, comprising over half of all cancers in females.
  - o Cancers of the **head and neck region** accounted for **nearly one third (31.2%) of the cancers among males.**
  - o Cancers in sites associated with **tobacco use comprised 48.7% of cancers among males** and 16.5% among females.
  - o Childhood cancers constitute 7.9% of all cancers.

## 113. (b)

**[SOL] Option B is Correct:** They are food derived from aquatic or marine animals, plants or algae that are caught or cultivated in freshwater and marine environments.

- Examples
  - o Seaweeds, Sea Cucumber

## 116. (a)

[SOL] Ishwar Chandra Bandyopadhyay was born on 26 September 1820 in Birsingha village of Midnapore district, West Bengal.

- His father Thakurdas Bandyopadhyay and mother Bhagavati Devi were very religious persons.
- He spent his childhood days in **abject poverty** as the economic condition was not that stable
- He was a part of the larger social movement called the **Bengal Renaissance**, which started with the **enlightened leadership of Raja Rammohan Roy**.
- He brought a revolution in the education system of Bengal.
  - o In his book, "Barno-Porichoy" (Introduction to the letter), Vidyasagar refined the Bengali language and made it accessible to the common strata of the society.
- He used to **spend a part of his scholarships** and salary for the welfare of those poor people. He would also buy medicine for the sick.
- He proposed and pushed for the Widow Remarriage Act of 1856 in India and raised concern for the abolition of child marriage and polygamy.
- He also opened the doors of the colleges and other educational institutions to lower caste students, which was earlier reserved only for the Brahmins.
  - o For his immense generosity and kind-heartedness, people started addressing him as "Dayar Sagar" (ocean of kindness).

## 117. (d)

**[SOL] Statement 1 is correct:** Prime Minister Narendra Modi announced SAUBHAGYA on September 25, 2017. It is **one** of the **world's largest electrification drives.** 

- The scheme envisages electricity connection for each household by drawing a service
  cable from the nearest electricity pole to the home, installing an energy meter, and wiring for
  a single light point with an LED bulb and a mobile charging point.
- It aims to achieve Universal Household Electrification in the country by establishing lastmile connectivity and delivering power to all un-electrified rural families and poor urban households.
- Statement 2 and 3 are correct: It covers both urban and rural households. The beneficiaries for free electricity connections would be identified using Socio-Economic and Caste Census (SECC) 2011 data.
  - o However, un-electrified households not covered under the SECC data would also be provided electricity connections under the scheme on payment of Rs. 500 which shall be recovered by DISCOMs in 10 instalments through electricity bill.
- The Government of India largely provided funds for the Scheme to all States/UTs.

• The Competition Commission of India (CCI) recently fined 3 beer companies and then gave them a varying degree of relief

[SOL] The Cauvery (also spelt as 'Kaveri'), known as 'Ponni' in Tamil.It rises in the Brahmagri range of the Western Ghats and it reaches the Bay of Bengal in the south of Cuddalore, in Tamil Nadu. Its main tributaries are Amravati, Bhavani, Hemavati and Kabini. The Cauvery basin is spread in the states of Karnataka, Tamil Nadu and Kerala and the Union Territory of Puducherry.

#### 122. (d)

[SOL] Statements 1, 2 and 3 are correct: It is an inflammation of the membranes that surround the brain and spinal cord. It is predominantly caused by bacterial and viral infections.

- It is a devastating disease and remains a major public health challenge.
- The disease can be caused by many different pathogens including bacteria, fungi or viruses, but the highest global burden is seen with bacterial meningitis.
- It **kills a tenth of those infected** mostly children and young people and leaves a fifth with long-lasting disabilities, such as seizures, hearing and vision loss, neurological damage, and cognitive impairment.
- Meningitis epidemics have occurred in the last decade in all regions of the world.
  - o But it is most common in the 'Meningitis Belt,' which spans 26 countries across sub-Saharan Africa.



- The bacteria that cause meningitis are transmitted from person to person through droplets of respiratory or throat secretions from carriers.
- Several vaccines protect against meningitis, including meningococcal, Haemophilus influenzae type b and pneumococcal vaccines.
  - o However, not all communities have access to them. Many countries are yet to introduce them into their national programmes.
- Research is underway to develop vaccines for other causes of meningitis, such as Group B Strep bacteria.

## [SOL] In News

- The Union Minister of Health and Family Welfare along with the Minister of Fisheries, Animal Husbandry and Dairying has launched NAPRE on World Rabies Day.
- Statement 1 is not correct. It is a Viral disease spreading through dogs, monkey bats and many other mammals' bite.
- **Statement 2 is correct.** The Rabies is also known as "Hadakwa", "mad dog disease" or "Hydrophobia".
- **Statement 3 is not correct.** The government has recently launched an action plan for Rabies elimination by 2030.

## **124.** (c)

**[SOL] Statement 1 is not correct:** Pradhan Mantri Kisan Urja Suraksha evem Utthan Mahabhiyan (PM KUSUM) Scheme was launched in **2019** to help farmers access reliable daytime solar power for irrigation, reduce power subsidies, and decarbonise agriculture.

Statement 2 is not correct: It was launched by the Ministry of New and Renewable Energy (MNRE). The Scheme consists of three components:

- **Component A:** 10,000 MW of Decentralized Ground Mounted Grid Connected Renewable Power Plants of individual plant size up to 2 MW.
- **Component B:** Installation of 17.50 lakh standalone Solar Powered Agriculture Pumps of individual pump capacity up to 7.5 HP.
- **Component C:** Solarisation of 10 Lakh Grid-connected Agriculture Pumps of individual pump capacity up to 7.5 HP.

#### 125. (d)

**[SOL] Statement 1 is correct:** Independent legislators are prevented from joining a political party.

**Statement 2 is correct:** Nominated legislators are given six months' time to decide if they want to join a party.
