Cabinet approved setting up of WHO Global Centre for Traditional Medicine at Jamnagar, Gujarat

The Union Cabinet, chaired by Prime Minister Narendra Modi has approved the establishment of a World Health Organization Global Centre for Traditional Medicine (WHO GCTM) at Jamnagar, Gujarat.

An agreement was signed by the Government of India with the world body in this regard. The move would help develop norms, standards, and guidelines in relevant technical areas, tools and methodologies for collecting data undertaking analytics and assessing impact.

The WHO GCTM, to be established under the Ministry of AYUSH (Ayurveda, Yoga, Naturopathy, Unani, Siddha, Sowa-Rigpa and Homoeopathy), will be the first and only global outposted centre (office) for traditional medicines.

MV Ram Prasad Bismil became longest vessel to sail from Ganga to Brahmaputra via Bangladesh

The Ministry of Ports, Shipping & Waterways has attained a landmark achievement by sailing the Motor Vessel Ram Prasad Bismil, the longest vessel ever to sail on the river Brahmaputra.

The vessel is 90 meters long flotilla is 26 meters wide, loaded with a draft of 2.1 meters. With this, it successfully completed the aspiring pilot run of heavy cargo movement from Haldia Dock in Kolkata to Pandu Port, Guwahati, Assam.

Nitin Gadkari launched India's 1st Green Hydrogen Fuel Cell EV 'Toyota Mirai'

Union Minister for Road Transport and Highways, Nitin Gadkari has inaugurated the world's most advanced technologydeveloped Green Hydrogen Fuel Cell Electric Vehicle (FCEV) Toyota Mirai at New Delhi.

Toyota Mirai is India's first Fuel Cell Electric Vehicle (FCEV), which is completely powered by Hydrogen.

Toyota Mirai has been launched by Toyota Kirloskar Motor Pvt Ltd and International Center for Automotive Technology (ICAT) under a pilot project, to study and evaluate the performance of Toyota Mirai on Indian roads and climatic conditions.

This is a first of its kind project in India which will create a Green Hydrogen based ecosystem in the country and help India to become 'Energy Self-reliant' by 2047.

India's first ever GI-tagged Kashmir carpets flagged off to Germany

The Government of Jammu and Kashmir has launched quick response (QR) code for its GI-tagged Kashmiri carpet, to preserve the authenticity and genuineness of the hand-knotted carpets.

The main objective of this QR Code attached to the GI tag is to help in reviving the sheen and glory of the Kashmiri carpet industry.

The first-ever consignment of GI-tagged hand-knotted carpets were exported to Germany from New Delhi on March 11, 2022. It must be noted that the Kashmiri carpets were granted GI-tag in June 2016 by the Geographical Indication Registry of the Department of Industry Promotion and Internal Trade, Ministry of Commerce and Industry, but the registered carpets were certified from 2022.


15 March: International Day to Combat Islamophobia

The 193-member United Nations General Assembly (UNGA) has adopted a resolution to proclaim 15 March as the International Day to Combat Islamophobia every year, starting from 2022.

The resolution regarding International Day to Combat Islamophobia was introduced by Pakistan's permanent representative to United Nations (UN), Munir Akram.

The resolution was introduced on behalf of the Organization of Islamic Cooperation (OIC) countries, under the agenda item Culture of peace. The resolution was sponsored by 57 member states of the Organization of Islamic Cooperation (OIC) and eight other countries including China and Russia.

India's Permanent Representative to the United Nations (UN) Ambassador T S Tirumurti, expressed concern over phobia against one particular religion being elevated to the level of an international day.

18 March: Ordnance Factory Day

Ordnance Factory Day is observed across India on 18 March to commemorate the foundation of the first ordnance factory at Cossipore near Kolkata in year 1801.

The erstwhile ordnance factories, which operated under the Ministry of Defence (MoD), were responsible for supplying arms, ammunition and clothing to the country's armed forces.

The Indian Ordnance Factory Board (OFB), which comprised 41 institutions, ceased to exist from 1 October last year. The OFB was split into seven public sector undertakings (PSUs), which continue to supply the country's armed forces with a variety of military equipment.
