## The Most Important Current Affairs June 2023

### International Yoga Day 2023

**International Yoga Day** is celebrated every year on **June 21st** to promote the numerous benefits of practicing yoga. The chosen date coincides with the summer solstice, the longest day of the year in the Northern Hemisphere. This day serves as a platform to raise awareness about the holistic approach to well-being that yoga offers. It highlights the importance of finding balance in our fast-paced, modern lives and encourages physical, mental, and spiritual harmony. Yoga fosters mindfulness, stress reduction, and overall health and vitality.

In its **9th edition**, this year's International Day of Yoga will be led by Prime Minister Narendra Modi at the UN Headquarters on June 21st. This marks the first time a yoga session will be conducted by the Prime Minister at this location.

### International Yoga Day 2023 Theme

The theme selected for this year's International Day of Yoga 2023 is **"Yoga for Vasudhaiva Kutumbakam,"** which represents our shared desire for "One Earth, One Family, One Future."

### International Yoga Day 2023 Significance

The Indian Institute of Technology (IIT), Madras has retained the top spot in the **National Institute Ranking Framework (NIRF), 2023** for the fifth consecutive year, while the Indian Institute of Science (IISc), Bengaluru has been ranked as the best university, according to the Ministry of Education. IISc Bengaluru has bagged the second spot in the "overall" category followed by IIT Delhi.

**RBI Monetary Policy June 2023: All Important Highlights**

The **RBI Monetary Policy meeting** is held for June 2023. The **Reserve Bank of India (RBI)** declared its second instance of maintaining the interest rates at the same level, indicating successful outcomes from RBI monetary policy measures. RBI Governor **Shaktikanta Das** announced that the repo rate would remain unchanged at 6.5%. He further stated that India's Consumer Price Index (CPI) inflation has decreased in recent months, and the GDP forecast for the current fiscal year remains unchanged.

**RBI Monetary Policy June 2023: Key Highlights**

- The **Monetary Policy Committee (MPC)** expressed its worry regarding persistent inflation, which could be a concern due to uncertain monsoon patterns, fluctuations in global commodity prices, and volatility in the international financial markets.
- The **Reserve Bank of India (RBI)** estimated that the Consumer Price Index (CPI) inflation for the fiscal year 2024 would be around 5.1 percent. Additionally, the GDP growth rate for FY24 was projected to be 6.5 percent.
- In other developments, the RBI authorized banks to issue Rupay prepaid forex cards and expanded the usage of e-rupee vouchers for non-banking companies.
- The minutes of the MPC's meeting will be made public on June 22.
- The Monetary Policy Committee (MPC) has announced that it will maintain the repo rate at 6.5%.
- The Standing Deposit Facility Rate remains at 6.25%, while the Marginal Standing Facility Rate and Bank Rate remain unchanged at 6.75%.
- All members of the MPC, including Dr. Shashanka Bhide, Dr. Ashima Goyal, Jayanth R. Varma, Rajiv Ranjan, Michael Debabrata Patra, and Shaktikanta Das, unanimously voted to keep the policy repo rate unchanged at 6.5% for the second time.

**RBI Monetary Policy: CPI Inflation**

The **Reserve Bank of India (RBI)** has projected the **Consumer Price Index (CPI) inflation** for the fiscal year 2024 to be 5.1%. Inflation is expected to remain above the RBI's target of 4% throughout 2023-24 due to factors such as uncertainty in the monsoon season, international commodity prices, and financial market volatility.

Expressing concerns about rising inflation, the RBI Governor mentioned that inflation continues to pose a risk to the economy, considering the uncertainties mentioned earlier.

**RBI Monetary Policy: GDP Growth Rate of India in 2023-24**

The **GDP growth rate for India in 2023-24** will be kept at 6.5% by the RBI MPC. On a quarterly basis, the GDP growth rate is projected to be 8% in Q1FY24, 6.5% in Q2FY24, 6% in Q3FY24, and 5.7% in Q4FY24.

The RBI assures that it will maintain liquidity management and ensure the orderly completion of the government's market borrowing program within the specified timeframe.

Governor **Shaktikanta Das** stated that the MPC will take necessary monetary actions to anchor inflation expectations. Additionally, the real policy rate will remain positive, and the average system liquidity is still in surplus mode. It is expected to increase further as ₹2,000 banknotes are deposited in banks.

**RBI Monetary Policy: Rupay prepaid Forex cards**

The **Reserve Bank of India (RBI)** has authorized banks to issue Rupay prepaid forex cards. Additionally, the RBI has announced plans to expand the use of e-rupee vouchers, allowing non-bank companies to issue similar instruments independently.

Governor **Shaktikanta Das** emphasized that the RBI will actively monitor and address emerging risks to both price stability and financial stability.

**RBI Monetary Policy: Net FPI inflow in FY24**

According to RBI Governor Shaktikanta Das, the net inflow of **Foreign Portfolio Investments (FPI)** in the fiscal year 2023-2024 until June 6 amounts to \$8.4 billion. In comparison, the net FPI inflow was \$14.1 billion in 2021-2022 and \$5.9 billion in 2022-2023.

**RBI Monetary Policy: Surplus Liquidity**

- The average daily borrowings through the liquidity adjustment facility (LAF) between April and May amounted to ₹1.7 lakh crore, indicating less surplus liquidity compared to the ₹2.9 lakh crore observed throughout the entire fiscal year 2022-23.
- **Shaktikanta Das**, the governor of the Reserve Bank of India (RBI), explained that various factors contributed to this reduction, including the maturity of targeted longer-term refinancing operations (TLTROs).
- Additionally, the seasonal increase in money circulation and the accumulation of government cash balances during this period helped moderate the excess liquidity.
- However, starting from the third week of May, the liquidity in the system increased due to higher government spending and a decrease in the amount of money in circulation.
- The RBI's market activities and the deposit of ₹2,000 banknotes in banks further added to this liquidity increase.
- The presence of surplus liquidity and the higher utilization of the **marginal standing facility (MSF)** by some banks indicate an uneven distribution of liquidity within the banking sector.
- To address this situation, the RBI conducted two 14-day **variable rate reverse repo (VRR)** auctions in February and March 2023, each totaling ₹50,000 crore.

In order to take prompt action on liquidity, the Reserve Bank conducted several VRR auctions, including a 14-day auction on June 2 for ₹2.0 lakh crore, a 4-day auction on June 5 for ₹1.0 lakh crore, a 3-day auction on June 6 for ₹75,000 crore, and a 2-day auction on June 7 for ₹75,000 crore. However, the response to these auctions has been cautious.

### Mumbai Tops the List as India's Costliest City for Expatriates

#### Why Mumbai in news?

According to Mercer's Cost of Living survey, **Mumbai** has been identified as the most expensive city for expatriates in India. The survey analyzed 227 cities across five continents to determine the cost of living for expats. Following **Mumbai, New Delhi and Bengaluru** ranked second and third respectively on the list.

#### Global Ranking and Asian Comparison

In the 2023 survey, **Mumbai was positioned at 147 in the global ranking, with New Delhi at 169, Chennai at 184, Bengaluru at 189, Hyderabad at 202, Kolkata at 211, and Pune at 213.** Interestingly, Mumbai and Delhi were noted as cost-efficient destinations for multinational corporations (MNCs) due to their lower cost of living and expat accommodation costs compared to major cities in the Asia Pacific region like Shanghai, Beijing, and Tokyo.

On a global scale, the most expensive cities for expats were **Hong Kong, Singapore, and Zurich**. The survey assessed the cost of various items in each location, including housing, transportation, food, clothing, household goods, and entertainment. This data helps employers design fair and effective compensation packages for international assignees in over 400 locations worldwide.

#### Mumbai's Position in Asia and Global Ranking

In Asia, **Mumbai and Delhi ranked among the top 35 most expensive cities for expats.** However, Mumbai dropped one spot within Asian cities, moving to the 27th position compared to the previous year's ranking.

Among Indian cities surveyed, Mumbai had the highest cost of living for expats. However, cities like Chennai, Hyderabad, Kolkata, and Pune offer significantly lower accommodation costs compared to Mumbai, with Kolkata being the most affordable option for residents and expatriates.

The survey also highlighted the least expensive locations, including Havana (which dropped 83 spots due to currency devaluations) and two cities in Pakistan, Karachi, and Islamabad.

Overall, Mercer's Cost of Living survey provides valuable information for employers to design fair compensation packages and helps expatriates understand the cost of living in various cities worldwide.

### French Open 2023: Novak Djokovic beats Casper Ruud

**Novak Djokovic** won his men's-record **23rd Grand Slam title** with a victory over **Casper Ruud** in French Open Final. Djokovic broke a tie with rival Rafael Nadal for the most major singles trophies in the history of men's tennis. The Serb moves into the outright lead of men's majors ahead of Rafael Nadal. He also becomes the first man to win all four majors at least three times. By winning his 23rd Slam title at the French Open beating Norwegian world No. 4 Casper Ruud 7-6(1), 6-3, 7-5 in the final. Djokovic broke away from Rafael Nadal in the men's pecking order. Joining Serena Williams on the most Slam count by any player in the Open Era, he also became the first man to win all the Majors at least thrice.

This year, the **Roland Garros tournament or French open** has seen a significant increase in the total prize money, reaching an impressive €43.9 million. This reflects a notable rise of 13.76 percent compared to the previous year. As a result of his outstanding performance at the tournament, Djokovic will be awarded a prize money of **€2,300,000 (\$2,496,039)**, which is a 4.55 percent increase from the amount given twelve months ago. The runner-up, Casper Ruud, will receive **€1,150,000 (\$1,248,019)** as a recognition of his commendable efforts in the competition.

### Australia Crowned with ICC World Test Championship 2023

**Australia** clinched the title of World Test Champions in a commanding fashion, securing a resounding 209-run victory over **India** in the thrilling **WTC Final** at **The Oval**. Travis Head and Steve Smith's remarkable centuries in the first innings laid the foundation for Australia's early control of the Test. Despite India's valiant response, the match extended to a fifth day, but they fell short of an extraordinary record chase, ultimately being bowled out for 234. Australia scripted history on Sunday, June 11 as they became the first men's team in world cricket to win an International Cricket Council (ICC) world title in all three formats.

**Player of the Match:** Travis Head (163 off 174 balls in 1st innings, 18 off 27 balls in 2nd innings). Australia won the ICC Test Championship mace for the first time, and were also awarded the cash prize of US\$1.6 million, while India won US\$800,000.

### ICC Player of the Month for May 2023 revealed

#### ICC Men's Player of the Month for May 2023

**Harry Tector** has been selected as the **ICC Men's Player of the Month for May**, marking Ireland's first-ever recipient of the award. He emerged victorious in a tough competition against the renowned Pakistani cricketer **Babar Azam** and Bangladesh's promising young batter **Najmul Hossain Shanto**. On the other hand, the ICC Women's Player of the Month for May 2023 has been awarded to **Thipatcha Putthawong (Thailand)**, a talented 19-year-old player. She follows in the footsteps of her compatriot Naruemol Chaiwai, who won the award last month. Both players were selected as the standout performers following a vote conducted among a specialist panel comprising ICC Hall of Famers, former international players, and media representatives, and global cricket fans registered at icc-cricket.com, who had been voting since the nominees were announced last week.

#### Important points

- Tector has been enjoying a sustained period of good batting form in One-Day International (ODI) cricket dating back to July 2022, and his recent run-scoring feats have seen him shoot up to a highest-ever position of seventh spot in the MRF Tyres ICC Men's ODI batting rankings.

- Newly crowned ICC Women's Player of the Month Thipatcha Putthawong became Thailand's latest winner of the award following a flurry of impressive bowling figures in her country's gold-medal winning performance at the Southeast Asian (SEA) Games in Phnom Penh, Cambodia in May. The left-arm took 11 wickets in four T20Is during the performance period at a staggering average of 1.54, enjoying successive spells of four wickets for three runs, three for three, and three for two against the Philippines, Malaysia and Myanmar respectively in Thailand's surge to gold.

### Community Spirit Index: Indian City Is Ranked Second Most Unfriendly City In the World

In the recent ranking by the **Community Spirit Index**, 53 cities from different countries have been given ranks based on how friendly and unfriendly their residents are. For this purpose, 6 metrics have been considered. Toronto and Sydney are named the world's top friendliest countries in the index while India's capital New Delhi and Mumbai are among the most unfriendly cities in the world.

New York, Dublin, Copenhagen, Montreal and Manchester are also among the world's top friendliest countries. India's financial capital Mumbai is ranked the second most unfriendliest city in the world by Preply which prepared the Community Spirit Index.

Accra in Ghana was ranked as the least friendly city in the world for non-natives, with a friendliness score of just 3.12 out of 10. Marrakech in Morocco ranks at 2 as the second least friendly city in the world with a score of 3.69, followed by Mumbai, Kuala Lumpur, Rio de Janeiro, and Delhi. Mumbai has 3.91 per cent "friendly staff" while Delhi has 3.27 per cent, according to the index. Mumbai scored 3.78 for happiness while Delhi was at 4.01.

India, despite experiencing a slight drop of three ranks, finishes in 40th place in the 2023 Global Competitiveness Index, indicating an improvement compared to its consistent 43rd position between 2019 and 2021. The IMD report highlights several areas of advancement and challenges faced by India in its pursuit of competitiveness.

1. **Ireland's Remarkable Leap:** Ireland's ascent from 11th to second place demonstrates its commitment to competitiveness. The country's access to markets and trading partners has played a pivotal role in its remarkable progress.
2. **Singapore's Consistency:** Despite falling one spot to fourth place, Singapore remains a highly competitive economy. The country's ability to leverage its market access and maintain consistency in competitiveness is commendable.
3. **India's Progress:** India, ranking 40th, experienced an improvement from its previous position of 43rd. Notable strengths for India include exchange rate stability, compensation levels, and advancements in pollution control. However, there are challenges to address, such as maintaining high GDP growth, controlling inflation and fiscal deficit, and accelerating digital transformation.



### Challenges and Regional Insights:

- Europe's Prominence:** European economies dominated the top 10 rankings in 2023, with five countries featured. Denmark, Switzerland, Ireland, Netherlands, and Sweden showcased their competitive prowess, although Sweden slipped four places from the previous year.
- South American Lag:** Six South American countries occupied the bottom 10 positions in the index, with Venezuela ranking last at 64th place. Argentina, Mongolia, South Africa, Brazil, Botswana, and Colombia also faced competitiveness challenges.

Zurich, Switzerland, has also made significant strides, rising ten places to reach #36, marking the most substantial year-on-year improvement in Europe.

#### RBI's Financial Stability Report Highlights Strong Performance of Indian Banking Sector

The Reserve Bank of India (RBI) recently released its 27th **Financial Stability Report (FSR)**, presenting an assessment of the Indian financial system's resilience and risks. Despite global uncertainties and challenges, the Indian economy continues to display robust growth supported by strong macroeconomic fundamentals. The banking sector, in particular, has performed well, outshining the turmoil experienced by advanced economies.

#### Here are the key highlights from the report:

1. **Robust Deposit Growth:** Exceeding 10% Threshold Aggregate deposit growth, which had experienced a slight moderation in the previous two years, regained momentum and crossed the 10% mark, reaching 11.8% as of June 2, 2023. The primary driver of this growth was private-sector banks, as term deposits attracted healthy accretions in the rising interest rate cycle. Consequently, current account and savings account (CASA) deposits experienced a relative decline.
2. **Impressive Credit Growth:** Surpassing 15% Benchmark The banking sector witnessed remarkable credit growth, driven equally by public sector banks and private banks. Credit growth reached an impressive 15.4%, with significant contributions from the personal loan segment. Personal loans, encompassing housing, credit card receivables, vehicle/auto loans, and education loans, experienced broad-based growth of 22.2% year-on-year.
3. **Enhanced Asset Quality:** GNPA Reaches Decadal Low Banks have successfully improved their asset quality by reducing the proportion of non-performing assets. Scheduled commercial banks (SCBs) continued to enhance their asset quality, with the gross non-performing assets (GNPA) ratio falling to a 10-year low of 3.9% in March 2023. Additionally, the net non-performing assets (NNPA) ratio improved to 1.0%, a level last seen in June 2011.

4. **Decline in Large Borrowers:** Retail Loans Gain Traction Over the past three years, the share of large borrowers in the gross advances of SCBs has consistently decreased. It dropped from 51.1% in March 2020 to 46.4% in March 2023, primarily due to the faster growth of retail loans compared to corporate borrowings. Consequently, the share of large borrowers in the GNPA of SCBs also substantially declined.
5. **Profit Margin Boost:** Higher Net Interest Margin and Strong PAT Growth During the period of 2022-23, banks experienced a 30 basis points improvement in net interest margin (NIM), as the transmission of monetary policy tightening to deposit rates lagged behind the pass-through to lending rates. This resulted in a healthy 38.4% year-on-year growth in bank's profit after tax (PAT), driven by a significant increase in net interest income (NII) and reduced provisions.

Scheduled commercial banks (SCBs) witnessed historical highs in capital to risk-weighted assets ratio (CRAR) and common equity tier 1 (CET1) ratio. As of March 2023, the CRAR stood at 17.1%, while the CET1 ratio reached 13.9%.
