This year is the 'Dungyur Torgya' festival, which marks special occasion as every 3rd year, the festival is organised on a broader level with the name Dungyur Festival during which Dalai Lama offers blessings (also known as Tse-Boom) to other lamas by sending Feb Jum which is a holy item to be used in rituals.

The main attractions of the festival is the 'Sha-na Cham', the ritual dance performed by monks to showcase the Choe-gyal Yap & Yum Tsa-Munde deity.

India's first geological park will be built in Lamheta, Jabalpur in Madhya Pradesh

The Geological Survey of India (GSI), Ministry of Mines, approved the setting up of India's first geological park at Lamheta village, on the banks of the Narmada River in Jabalpur, Madhya Pradesh.

The GSI has sanction Rs. 1.30 crore for the formation of Geopark in 5 acres of land at the Lamheta village which is located 20 km away from the Jabalpur district headquarters.

The estimated cost of this project is Rs 35 crore and any additional funds can be sanctioned if required.


This geopark to be formed in MP is already in the United Nations Educational, Scientific and Cultural Organisation (UNESCO) geoheritage tentative list for the conservation of the natural heritage. In 1828, the 1st dinosaur fossil was collected from the Lameta Bed by Indian Civil Service (ICS) officer William Sleeman.

Khijadia Wildlife Sanctuary in Gujarat & Bakhira Wildlife Sanctuary in UP listed as India's 48th & 49th Ramsar sites

Khijadia Wildlife Sanctuary in Gujarat and Bakhira Wildlife Sanctuary in Uttar Pradesh were declared as two new Ramsar sites (Wetlands of International Importance).

With this, the total number of Ramsar sites in India goes up to 49. Khijadiya, which is part of the Central Asian Flyway, has become the 4th wetland of Gujarat to get the Ramsar tag.

Bakhira Wildlife Sanctuary, a freshwater marsh in the Sant Kabir Nagar district. It is the largest natural floodplain wetland of eastern Uttar Pradesh.


PM Narendra Modi hosted first India-Central Asia Summit 2022

Prime Minister of India Narendra Modi hosted the 1st India-Central Asia Summit 2022 in a virtual format with the Presidents of 5 Central Asian Nations of Kazakhstan, Kyrgyz Republic, Tajikistan, Turkmenistan and Uzbekistan.


This summit, also the first engagement of its kind between both sides at the level of leaders, coincided with the 30th anniversary of the establishment of diplomatic relations between them.


It highlights India's growing cooperation with Central Asian countries as a part of its 'Extended Neighbourhood'.

The leaders reiterated their support for a peaceful, secure and stable Afghanistan. They also agreed to set up Joint Working Groups (JWG) at senior official level on Afghanistan.

Netherlands unveiled 'world's-largest' canal lock

World's-largest canal lock unveiled in Netherlands. Canal lock was inaugurated by Dutch King Willen-Alexander.

The 500-meter long and 70-meter-wide sluice replaces a smaller, nearly 100-year-old one at limuiden. Ijmuiden is a small port city connecting the North Sea Canal to the port of Amsterdam.

The overall cost of constructing the project is \$338 million. The Ijmuiden lock was designed to allow large, modern cargo ships to reach the port of Amsterdam.

India and Nepal signed a Memorandum of Understanding for the construction of a motorable Bridge over the Mahakali River, connecting Dharchula (India) with Darchula (Nepal), under Indian grant assistance.


This agreement was signed by Ambassador of India, Vinay Mohan Kwatra, and Secretary, Ministry of Physical Infrastructure and Transport, Government of Nepal, Rabindra Nath Shrestha.

The project will enhance cross-border connectivity between the Sudurpaschim province of Nepal and the Uttarakhand state of India across the Mahakali River where close people-to-people links exist between communities on both sides of the border.

CRISIL projected India's GDP to grow at 7.8% in FY23

Domestic rating agency CRISIL estimated FY 2022-23 real GDP growth at 7.8% as compared with the 8.5% projected in the Economic Survey.

This estimate is owing to Budget proposals focused on loosening the purse strings by boosting capital expenditure and going slow on fiscal consolidation.

The agency said global growth is expected to slow this year as major economies see a withdrawal of monetary and fiscal stimulus.

Lieutenant General GAV Reddy has been appointed as the new head of the Defence Intelligence Agency.



The Economic Survey has projected a growth rate of 8-8.5% for next financial year ending March 2023.

The Economic Survey 2021-22 was tabled by Finance Minister Nirmala Sitharaman in Lok Sabha on 31 January, while the Budget will be presented on 1 February at 11 am.

The survey expectations for next fiscal year are conservative compared to 9% expansion seen by IMF.

For the current financial year, the survey projects a growth rate of 9.2%, led by 11.2% growth in industrial sector and 8.2% growth in services sector. Agriculture sector growth is seen at 3.9% in FY22.

The monthly GST collections in January 2022 crossed Rs 1.30 lakh crore for the fourth time in the history of GST.

The collections in January 2022 till 3 pm on 31 January 2022 was at Rs 1,38,394 crore. January 2022 collections were 15 per cent higher than collections in the same month last year and 25 per cent higher than the GST revenues in January 2020.

Of the Rs 1,38,394 crore, CGST accounted for Rs 24,674 crore, SGST Rs 32,016 crore, IGST Rs 72,030 crore (including Rs 35,181 crore collected on import of goods) and compensation cess accounted for Rs 9,674 cr (including Rs 517 cr collected on import of goods).
