1) Correct Answer: (b) Linear Induction Motor for Pod Propulsion

Explanation

- **Core Concept:** Hyperloop uses **vacuum tubes, magnetic levitation, and Linear Induction Motors (LIM)** for ultra-high-speed transport.
- **Key Features:**
 - LIM generates propulsion through a moving electromagnetic field.
 - Low-pressure tubes minimize drag.
 - Magnetic levitation ensures frictionless, smooth travel.
- **Why (b) is Correct:** LIM is the **core propulsion technology** in hyperloop systems.
- **Why Others are Wrong:**
 - (a) Helium not used.
 - (c) Not based on conventional rail tracks.
 - (d) No solar-powered steam engine in hyperloop.

2) Correct Answer: (a) Maintain Price Stability with Growth Consideration

Explanation
