

Weekly One Liners 7th to 13th April, 2025**Haryana Declares Two Harappan Sites as Protected Archaeological Monuments**

The Haryana government has officially declared two Harappan civilization sites located in **Bhiwani district — Mitathal and Tighrana** — as protected archaeological sites and monuments. These sites, dating back over 4,400 years, hold immense historical and cultural value, shedding light on the evolution of early agricultural societies, town planning, craft industries, and **trade during the Harappan and post-Harappan periods**. The sites have now been brought under legal protection through a notification issued by the Haryana Heritage and Tourism Department under the Haryana Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1964. The move aims to safeguard these ancient settlements from encroachment and damage, with fencing and security arrangements to be implemented.

- Notification issued on March 13, 2025, by Kala Ramachandran, Principal Secretary of Haryana Heritage and Tourism.

Mitathal Site (Harappan Civilization)

- **First discovered in 1913**, with a hoard of coins belonging to **Samudra Gupta (Gupta dynasty)**.
- Excavated in 1968, revealing the Copper-Bronze Age culture of the Indo-Gangetic divide (3rd–2nd millennia BCE).
- Excavations from 1965 to 1968 uncovered proto-historic material, including beads and copper implements.

Archaeological features

- Harappan-style town planning, architecture, arts, and crafts.
- **Pottery**: Sturdy red ware, well-burnt and painted in black with pipal leaf, fish scale, and geometric designs.
- **Artifacts**: Beads, bangles, terracotta, and objects made of stone, shell, copper, ivory, and bone.

Tighrana Site (Post-Harappan/Chalcolithic Culture)

- Settlement dating back to around 2,400 BCE.
- **Inhabited by Chalcolithic agricultural communities called Sothians**.
- Located at Chang, Mitathal, Tighrana, and nearby regions.

Settlement features

- Thatched-roofed mud-brick houses, possibly fortified.
- 50 to 100 houses per settlement.

Lifestyle and tools

- Agriculture and domestication of animals: cows, bulls, goats.
- Use of wheel-made ceramics, painted in bichrome black-and-white designs.
- Use of copper, bronze, and stone tools in large numbers.
- **Craft industry**: Presence of beads and green carnelian bangles indicates jewelry and bead-making trade.
- Discoveries include remains from Pre-Siswal, Pre-Harappan, and Post-Harappan periods — making it a significant chronological settlement site.

India-Sri Lanka Sign Historic Defense Pacts For The Future

India and Sri Lanka have taken a historic step in **strengthening their bilateral relations by signing a landmark defence cooperation pact, the first of its kind between the two nations**. This comes almost 40 years after the deployment of the Indian Peace Keeping Force (IPKF) in Sri Lanka during the civil conflict. The pact, signed during Prime Minister Narendra Modi's visit to Colombo and his discussions with Sri Lankan President Anura Kumara Dissanayake, reflects a shared strategic vision and growing interdependence on security and development matters. The pact is part of a wider framework of ten major agreements focusing on defence, energy, digital cooperation, and health, aimed at deepening the partnership between the two neighbouring countries.

New Pamban Bridge Inaugurated by PM Modi

This first vertical-lift sea bridge in the country replaces the century-old Pamban Bridge and stands as a marvel of modern engineering. The bridge, which connects **Rameswaram Island to Mandapam on the mainland**, is designed for both durability and technological excellence. The inauguration coincided with Ram Navami and PM Modi’s return from Sri Lanka, where he also had a divine aerial view of Ram Setu, symbolically linking the spiritual and structural achievements of the day.

“Women and Men in India 2024” Report Released by MoSPI

The “Women and Men in India 2024” report, released by the Ministry of Statistics and Programme Implementation (MoSPI), provides an in-depth overview of gender-specific data across various sectors in India. It offers valuable insights into the progress made and the persistent challenges women face. The report highlights advancements in education, financial inclusion, political participation, and health, while also addressing ongoing disparities, particularly in employment, leadership roles, and rural-urban access. The following analysis delves into the key findings, their implications, and areas requiring further intervention.

Key Findings from the Report

1. Education – Gender Parity Trends

Gender Parity Index (GPI)

- The GPI across education levels remains above 1.00, indicating higher female enrolment than male students.
- Primary Level: 1.03
- Upper Primary Level: 1.02
- Higher Secondary Level: 1.02
- Implication: Girls are increasingly participating in education at all levels, showcasing progress in gender parity in education.



2. Labour Force Participation (15+ years)

Female Labour Force Participation Rate (LFPR)

- **Under-representation in Leadership:** Women are still underrepresented in senior leadership roles in corporations and politics, despite advances in **education and entrepreneurship**.
- **Rural-Urban Imbalance:** Women in rural areas face slower progress in digital literacy, internet access, and healthcare compared to their urban counterparts.

Way Forward

- **Skilling and Employment:** Focus on upskilling women and creating formal job opportunities in high-value sectors such as IT, green energy, and digital finance.
- **Leadership Inclusion:** Implement affirmative actions to increase women’s representation in decision-making bodies, especially in corporate and political leadership.
- **Digital and Financial Literacy:** Expand outreach programs to improve financial and digital literacy among rural women.
- **Gender Data Monitoring:** Establish a Gender Data Monitoring Dashboard for tracking real-time progress and more effective policymaking.

RBI Monetary Policy 2025: Bi-Monthly Highlights

The Reserve Bank of India’s Monetary Policy Committee (MPC) has announced the outcome of its first policy review of the new financial year. RBI MPC voted unanimously for the repo rate to be reduced by 25 bps to 6%, effective immediately. The RBI MPC reduces the SDF rate to 5.75% and the MSF rate to 6.25%.

The Monetary Policy Committee (MPC) held its 54th meeting from **April 7 to 9, 2025** under the chairmanship of Shri Sanjay Malhotra, Governor, Reserve Bank of India. The MPC members Dr. Nagesh Kumar, Shri Saugata Bhattacharya, Prof. Ram Singh, Dr. Rajiv Ranjan, and Shri M. Rajeshwar Rao attended the meeting. The remaining meetings for this year are scheduled for June 4–6, August 5–7, September 29–October 1, December 3–5, and February 4–6.

India-UAE Strengthen To Enhance Strategic Partnership

Prime Minister Narendra Modi and Dubai Crown Prince Sheikh Hamdan bin Mohammed Al Maktoum held high-level discussions in New Delhi on April 8, 2025, aimed at enhancing the **India-UAE Comprehensive Strategic Partnership**. Their talks focused on strengthening cooperation in defence, coast guard operations, trade, technology, space, and people-to-people ties. Sheikh Hamdan's first official visit to India as crown prince marked a significant milestone in bilateral relations, underscoring shared strategic priorities and mutual economic interests.



- The **Waqf (Amendment) Act, 2025**, which received **Presidential assent on April 5, 2025**, marks a pivotal change in the **administration of Waqf properties in India**. Despite the increase, the **Ministry of Petroleum** confirmed that **retail prices** will remain unchanged as **public sector oil marketing companies (OMCs)** like **IOCL, BPCL, and HPCL** will absorb the cost. 
