### India's Extreme Poverty Rate Falls to 5.3% in 2022-23: World Bank Report

India has made remarkable strides in reducing extreme poverty, with the rate plunging to 5.3% in 2022-23 from 27.1% in 2011-12, according to the latest World Bank report. Despite the poverty line threshold being revised upwards to \$3 per day to account for inflation and purchasing power parity, India has successfully lifted 171 million people out of extreme poverty over the past decade. This achievement underscores the impact of sustained economic growth, social welfare initiatives, and targeted poverty alleviation programs.

#### Why in News?

The World Bank's recent report on poverty reduction in India draws global attention as it reveals substantial progress amid economic challenges. The updated poverty line of \$3 per day reflects a more realistic measure of deprivation, making India's success even more significant. With continued economic uncertainties and global risks looming, the report serves as a vital indicator of India's developmental trajectory and the effectiveness of its policies in addressing poverty and inequality.

#### Aim and Objectives

- To highlight India's substantial reduction in extreme poverty over the last decade.
- To understand the factors and policies contributing to this success.
- To analyze the updated poverty thresholds and their implications for policy and planning.

#### Background

- In 2011-12, India's extreme poverty rate stood at 27.1% based on the \$2.15 per day threshold.
- The World Bank revised the global extreme poverty line to \$3 per day (2021 PPP) to adjust for inflation and updated cost of living, raising the benchmark for poverty measurement.
- India's economic growth, combined with social welfare schemes such as free/subsidised food transfers, helped in reducing poverty.
- The rural-urban poverty gap has narrowed significantly, highlighting inclusive growth patterns.

#### Static Facts and Figures

- Extreme poverty rate (at \$3 per day) declined to 5.3% in 2022-23 from 27.1% in 2011-12.
- Around 54.7 million people lived below the \$3/day threshold in 2024, representing 5.44% of the population.
- The number of people lifted from extreme poverty during 2011-12 to 2022-23: approximately 171 million.

- Extreme poverty rate dropped from 16.2% to 2.3% at the \$2.15/day line.
- Rural extreme poverty fell from 18.4% to 2.8%, urban extreme poverty from 10.7% to 1.1%.
- The rural-urban poverty gap narrowed from 7.7 percentage points to 1.7 points, indicating reduced disparity.
- Five most populous states account for 54% of India's extremely poor population.
- India's real GDP as of FY25 remains about 5% below pre-pandemic levels but is expected to recover by 2027-28.

#### Overall Significance

- The decline in poverty highlights India's progress in social and economic development.
- Improved access to food and social welfare programs have been crucial in reducing deprivation.
- Narrowing rural-urban gap indicates more balanced growth across sectors and regions.
- The findings stress the importance of sustained policy support amid global economic uncertainties.
- Continued vigilance is required as global trade tensions and other risks could impact future growth and poverty reduction.

### India's population Reaches 1.46 billion, Fertility Drops Below Replacement Rate: UN Report

In 2025, India's population is **estimated to reach 1.46 billion**, making it the most populous country in the world. According to a report by the United Nations Population Fund (UNFPA), this number is expected to peak at 1.7 billion in the early 2060s and then slowly start to decline.

#### Drop in Fertility Rate

The report says that India's total fertility rate (TFR) has now **dropped to 1.9 births per woman**, which is below the **replacement level of 2.1**. This means Indian women are having fewer children than needed to maintain the population size from one generation to the next, without migration.

#### What the UN Report Says?

The United Nations Population Fund (UNFPA) released its 2025 State of World Population (SOWP) Report, titled **"The Real Fertility Crisis."** It explains that the world should not panic about falling fertility rates but focus on helping people meet their personal family goals.

#### Fertility Rate Falls Below Replacement Level

India's Total Fertility Rate (TFR) is now 1.9 births per woman, which is below the replacement level of 2.1. This means women in India are, on average, having fewer children than needed to keep the population stable in the long term.

### India's Population Will Peak Around 2064

According to the UN, India's population is expected to peak around the **early 2060s at about 1.7 billion**. After that, it will begin to slowly decline. As of now, India's population stands at 1.4639 billion.

### India's Changing Population Structure

India's population is going through big changes:

- 24% of people are aged 0-14 years
- 17% are aged 10-19 years
- 26% are aged 10-24 years
- 68% of the population is in the working age group (15-64)

This gives India a chance to benefit from a demographic dividend – where more people can work and grow the economy, if given good jobs and policies.

### Growing Elderly Population

Currently, **7% of the population is aged 65 and above**, and this number will rise as life expectancy increases.

Life expectancy in 2025:

- Men: 71 years
- Women: 74 years

### How Fertility Has Changed Over time?

In 1960, India's population was about 436 million and the average woman had nearly six children. Most women then had little control over their bodies and very few used contraception or went to school.

### But over time, things improved:

- More girls went to school
- Access to reproductive healthcare increased
- Women gained more voice in decisions

Now, Indian women have about two children on average, a major drop from past decades.

### Still a Long Way to Go

While Indian women today have more rights and choices than earlier generations, many still do not have full control over their reproductive decisions. Deep differences remain between rich and poor and across states and communities.



### A Message of Hope and Opportunities

Andrea M. Wojnar, UNFPA's India Representative, said that India has made great progress, especially in lowering fertility and saving mother's lives.

But the real success, she says, will come when everyone, no matter who they are, has the power to make informed choices about having children. India has a unique chance to lead the world in showing how reproductive rights and economic growth can go hand in hand.

**Remarkable Impact on Maternal Mortality Ratio (MMR)**

India's **Maternal Mortality Ratio** has seen a significant decline due to PMSMA and other aligned interventions:

- **MMR in 2014–16:** 130 per 1 lakh live births
- **MMR in 2021–23:** 80 per 1 lakh live births

This **50-point drop** demonstrates the success of targeted maternal health policies in enhancing safe motherhood.

**Aadhaar OTP Must for Tatkal Bookings from July 15**

In a major move to curb malpractices and ensure fair access to Tatkal tickets, the Ministry of Railways has announced that Aadhaar-based OTP authentication will be mandatory for booking Tatkal tickets on the IRCTC website and mobile app starting July 15, 2025. The updated rules also impose time-bound restrictions on agents and bring enhanced transparency to the reservation system.

**Why in News?**

The Railway Ministry declared the rollout of mandatory Aadhaar OTP authentication for all Tatkal bookings done online. The revised rules will be enforced from July 15, 2025. This move is aimed at reducing bulk bookings, deterring unfair practices, and ensuring genuine passengers benefit from the Tatkal scheme.

**New Tatkal Ticket Booking Rules**

**Aadhaar-based OTP Authentication**

- Mandatory for users booking Tatkal tickets online via the IRCTC website/app.
- OTP will be sent to the mobile number linked with Aadhaar.

**Tatkal Bookings at PRS Counters**

- Similar OTP-based authentication will apply at Passenger Reservation System (PRS) counters.
- The OTP will be sent to the mobile number provided during booking.

**Restriction on Booking Agents**

- IRCTC-authorized agents will not be allowed to book Tatkal tickets during the first 30 minutes of the opening window:
- AC classes: Blocked from 10:00 AM to 10:30 AM.
- Non-AC classes: Blocked from 11:00 AM to 11:30 AM.

**Objective of the Move**

- Prevent bulk booking and misuse of the Tatkal quota.
- Ensure genuine users can access high-demand tickets fairly.
- Enhance transparency and security through Aadhaar validation.
- Improve overall passenger convenience and experience.

**Implementation & Coordination**

Centre for Railway Information Systems (CRIS) and IRCTC will,

- Make technical modifications.
- Notify Zonal Railways and other stakeholders.
- Launch awareness campaigns before the new rule comes into effect.

**India's First Underwater Museum to Be Built Around INS Guldar in Maharashtra**

India is set to develop its first underwater museum and artificial coral reef around the decommissioned warship INS Guldar near Nivati Rocks, located off the coast of Vengurla in Sindhudurg district, Maharashtra. The project, supported by the Union Tourism Ministry with an outlay of ₹46.91 crore, aims to promote marine biodiversity conservation, eco-tourism, and underwater adventure tourism like scuba diving and submarine tours.

**Why in News?**

On June 11, 2025, Maharashtra CM Devendra Fadnavis virtually attended the launch of India's first underwater museum project, marking a significant step in promoting sustainable tourism and marine ecosystem restoration. The decommissioned INS Guldar, which served the Indian Navy until January 2024, has been handed over to the Maharashtra Tourism Development Corporation (MTDC) to transform it into a submerged attraction.

**Aims and Objectives**

- Convert INS Guldar into an underwater museum to promote marine tourism.
- Create an artificial coral reef to support marine biodiversity.
- Offer new tourism opportunities including scuba diving and future submarine tours.
- Preserve naval heritage by repurposing a historic vessel.

**About INS Guldar**

- INS Guldar was a 1,120-ton Landing Ship Tank (LST) in the Indian Navy.
- It was decommissioned in January 2024 after years of service.
- The ship has undergone environmental cleaning to make it suitable for submersion without harming marine ecosystems.

**Site and Environmental Impact**

- Nivati Rocks, Vengurla, in Sindhudurg district, has been chosen for its pristine waters and rich marine life.
- The ship will be scuttled (intentionally sunk) to serve as the foundation for coral reef formation.
- Artificial reefs help rejuvenate marine life, benefiting both biodiversity and local fisheries.

**Funding and Project Implementation**

- The Union Ministry of Tourism has sanctioned ₹46.91 crore for the initiative.
- The project is being implemented by Maharashtra Tourism Development Corporation (MTDC).
- The initiative aligns with India’s goals of promoting Blue Economy, eco-tourism, and sustainable development.

- Boosts coastal tourism and creates local employment opportunities.
