India Dominates Inaugural Kho Kho World Cup 2025

India has made history by clinching both the men's and women's titles at the inaugural **Kho Kho World Cup 2025**, held from **January 13 to 19** at the Indira Gandhi Arena in New Delhi. This landmark event featured 23 countries across six continents, with **20 men's and 19 women's teams** competing in the **fast-paced seven-a-side format**.

Men's Final: India vs. Nepal

In the men's final, India secured a commanding **54-36 victory over Nepal**. **Captain Pratik Waikar** and standout player **Ramji Kashyap** were instrumental in the win, with Waikar's exceptional skills and Kashyap's spectacular skydives keeping Nepal on the defensive. India's dominance was evident from the outset, with a **26-point lead in Turn 1**. Despite Nepal's efforts to stage a comeback in Turn 4, India's defense, led by **Waikar and Sachin Bhargo**, remained impenetrable.

Women's Final: India vs. Nepal

The Indian women's team mirrored their male counterparts' success by defeating **Nepal 78-40 in the final**. **Captain Priyanka Ingle** led with multiple touch points, establishing a strong foundation in **Turn 1**. A stellar **Dream Run by B Chaithra in Turn 4**, lasting over five minutes, sealed the victory. The women's team's journey to the title included impressive wins over South Korea, Iran, and Malaysia in the group stages, followed by commanding victories against Bangladesh in the quarterfinals and South Africa in the semifinals.

This double triumph underscores India's dominance in the sport, with both teams cementing their legacy as inaugural **Kho Kho World Cup champions**. Prime Minister Narendra Modi congratulated the teams, highlighting the historic nature of the victories and their potential to inspire future generations. Smriti Irani, Shekhar Kapur Join PM Museum Council

The **Prime Ministers' Museum & Library (PMML)** has undergone a significant reconstitution of its society and executive council, introducing several prominent figures to its leadership. Former Principal Secretary to the Prime Minister, Nripendra Mishra, has been reappointed as the chairperson for **another five-year term**.

Expansion of the Executive Council

The executive council, previously comprising 29 members, has been expanded to include 34 members. This expansion aims to bring diverse expertise and perspectives to the institution.

While Nripendra Mishra continues as chairperson, some previous members have not been reappointed, including former **Union Minister Anurag Thakur and journalist Rajat Sharma**. This reshuffle reflects a strategic move to infuse fresh perspectives into the institution's governance.

Historical Context

The PMML, formerly known as the Nehru Memorial Museum & Library (NMML), was renamed in 2023 to encompass the legacies of all Indian Prime Ministers. This reconstitution aligns with the government's vision to make the institution a comprehensive repository of India's political leadership history.

Uttarakhand Clears Uniform Civil Code Rules

Uttarakhand is set to become the **first state in India to implement the Uniform Civil Code (UCC)**, as the **state government has approved the UCC rules manual**. The state's Cabinet, headed by Chief Minister Pushkar Singh Dhami, cleared the manual and decided on key provisions related to registration services, the facilitation of live-in relationships, and the introduction of Tatkal services. The government is also implementing advanced digital platforms to ensure efficient and widespread access to these services. Training of officials is underway, with a statewide mock drill planned to prepare the stakeholders for smooth implementation.

Key Provisions of UCC's Rules

- **Scope of UCC:** It aims to unify laws governing marriage, divorce, inheritance, and maintenance across all faiths and communities in the state.
- **Online Portal and App:** A dedicated portal and mobile application have been developed to facilitate online registrations and services, ensuring greater public access and ease of use.

Key Services for Registration

- **Marriage Registration:** Registration of marriages and acknowledgment of registered marriages.
- **Divorce Registration:** Processes for the registration of divorces and nullifying marriages.
- **Live-in Relationships:** Registration of live-in relationships and their termination.
- **Inheritance:** Registration of intestate succession (legal heirs) and testamentary succession (wills).
- **Appeals:** Procedure for appealing decisions regarding applications.
- **Grievances:** A mechanism to file and track complaints.
- **Access to Information:** Access to data and information related to registered services.

Equality Provisions

- **Women's Rights:** Equal inheritance rights, rights to adoption, divorce, and polygamy bans.
- **Registration Requirements:** Compulsory registration/self-declaration for live-in relationships and marriages.
- **Legal Age for Marriage:** A standard marriageable age of **18 for women and 21 for men**.

Digital and Physical Access

- **CSC (Common Service Centres):** To assist in registration for those who are not digitally literate, especially in remote areas.
- **Helpline and Support:** A dedicated helpline and district-level officers for legal queries and portal-related issues.

Training and Implementation

- **Training and Development:** Uttarakhand is conducting extensive training programs for officials, with 10,000 village development officers (VDOs) expected to be trained by January 24, 2025.

Edelman Trust Barometer 2025 Rankings

The **Edelman Trust Barometer 2025**, an annual survey by the global communications firm Edelman, revealed key insights into public trust levels in government, businesses, media, and NGOs. This year, India has slipped one rank to the **third spot** globally in terms of overall trust, despite its score remaining unchanged. The study, released ahead of the **World Economic Forum Annual Meeting**, highlighted significant disparities in trust levels across income groups and nations.

Key Highlights of the Edelman Trust Barometer 2025

India's Position in Trust Rankings

India ranked third globally in terms of **trust in institutions** (government, businesses, media, and NGOs). The **top three positions** were as follows:

1. **China**
2. **Indonesia**
3. **India**
 - India lost its second position to **Indonesia**, which achieved an **increased score** despite India's score remaining stable.
 - India ranks **13th** in trust for **companies headquartered in Indian origin**, with **Canada, Japan, and Germany** topping this specific category.

Trust Gap Between Income Groups in India

The survey emphasized a stark gap between the **high-income and low-income populations**:

- Among the **high-income group**, India ranks **4th globally** after **Indonesia, Saudi Arabia, and China**.
- However, the **low-income group** trusts Indian institutions less, placing India in the **3rd position globally**, following **China and Indonesia**.

This **15% trust gap** highlights economic inequality and its impact on perceptions of institutional credibility.

Global Trends Highlighted in the Survey

Disparities Between Developed and Developing Nations

The survey revealed a stark contrast between trust levels in **developed and developing nations**:

Developing Nations:

- **China:** 77%
- **Indonesia:** 76%
- **India:** 75%
- **UAE:** 72%

Developed Nations:

- **Japan:** 37% (lowest globally)
- **Germany:** 41%
- **UK:** 43%
- **US:** 47%
- **France:** 48%

This data highlights a trend of **higher institutional trust in developing countries** as compared to wealthier nations.

RBI Tightens Guidelines for ARCs in Borrower Settlements

The Reserve Bank of India (RBI) has introduced stricter guidelines for **Asset Reconstruction Companies (ARCs)** to enhance transparency and accountability in borrower settlements. These revisions aim to standardize procedures and align them with practices of banks and **non-banking financial companies (NBFCs)**.

Key Revisions in Settlement Procedures

Board-Approved Policies: ARCs are now mandated to establish board-approved policies governing borrower settlements. These policies must detail eligibility criteria for one-time settlements, permissible sacrifices based on exposure categories, and methodologies for determining the realizable value of securities.

Independent Advisory Committee (IAC) Involvement: For borrowers with outstanding dues exceeding ₹1 crore, settlements require evaluation by an IAC comprising professionals with technical, financial, or legal expertise. The IAC will assess the borrower’s financial position, projected earnings, and recovery prospects before making recommendations.

Board Deliberations: The Board of Directors, including at least two independent directors, must deliberate on the IAC’s recommendations and evaluate alternative recovery options. The Board’s decision, along with detailed rationale, must be recorded in the meeting minutes.

Settlements Below ₹1 Crore: For dues of ₹1 crore or below, ARCs can process settlements based on criteria defined in the board-approved policy. However, officials involved in acquiring the financial asset cannot participate in the approval of the settlement to prevent conflicts of interest. Additionally, the Board must review quarterly reports detailing trends and recovery timelines for these accounts.

Enhanced Reporting and Compliance

Quarterly Reporting: ARCs are required to submit quarterly reports on the resolution of accounts, covering aspects such as trends in the number of accounts and amounts subjected to compromise settlements, categorization of fraud and wilful default cases, and recovery timelines.

Settlements Involving Wilful Defaulters or Frauds: Settlements involving borrowers classified as wilful defaulters or frauds will follow the same stringent procedures applicable to high-value accounts, irrespective of the settlement amount. This ensures no leniency in dealing with such borrowers while not prejudicing ongoing criminal proceedings.

Implementation and Compliance

These revised guidelines are effective immediately. ARCs must ensure compliance with the new procedures to maintain the integrity of the settlement process and protect consumer interests.

Tata Tops India, Apple Leads Globally in 2025 Brand Rankings

In the latest Brand Finance Global **500 report for 2025**, Tata Group has solidified its status as India’s most valuable brand, achieving a **brand value of \$31.6 billion—a 10% increase** from the previous year. This marks the first time an Indian brand has surpassed the **\$30 billion threshold**. Globally, Apple continues to dominate with a brand value of **\$574.5 billion, maintaining** its lead over competitors.

Tata Group’s Consistent Growth

Ranked 60th among the world’s top 100 brands, Tata Group has maintained its **AAA- brand strength rating**. This consistent performance underscores the conglomerate’s diversified business model and its ability to adapt to evolving market dynamics.

Surge of Indian Brands on the Global Stage

The report highlights significant advancements by other Indian brands:

Infosys: Achieved a 15% increase in brand value, reaching \$16.3 billion, and climbed to the 132nd position globally. Notably, Infosys has recorded the fastest compound annual growth rate (18%) among IT services brands over the past five years.

LIC: Emerged as the fastest-growing Indian brand with a 36% surge in brand value, totaling \$13.3 billion. The company boasts a Brand Strength Index score of 88 out of 100, the highest among Indian brands in the global ranking.

Reliance Group: Experienced a 17% growth in brand value, reaching \$9.8 billion, reflecting its expanding influence across various sectors.

Larsen & Toubro (L&T): Made a notable entry with a brand value of \$7.4 billion, highlighting its significant presence in the diversified sector.

1. **Apple:** Retains the top spot with a brand value of \$574.5 billion, an 11% increase from the previous year.
