### UNION BUDGET 2026-27

Union Minister for Finance and Corporate Affairs, Smt. Nirmala Sitharaman tabled the Union Budget 2026-27 in Parliament. This first Budget prepared in Kartavya Bhawan is inspired by three core principles that aim to drive India's economic growth, empower citizens, and ensure inclusive development.

#### Budget Estimates at a Glance

- **Non-debt receipts:** ₹36.5 lakh crore
- **Total expenditure:** ₹53.5 lakh crore
- **Centre's net tax receipts:** ₹28.7 lakh crore
- **Gross market borrowings:** ₹17.2 lakh crore
- **Fiscal deficit:** 4.3% of GDP (BE 2026-27)
- **Debt-to-GDP ratio:** 55.6% of GDP
- **Public capital expenditure:** ₹12.2 lakh crore

**WPL Titles in 2026**

The **Women's Premier League 2026** final delivered one of the greatest matches in women's T20 history. **Royal Challengers Bengaluru (RCB)** chased down a massive 204-run target, the highest successful chase ever in the WPL, to defeat Delhi Capitals (DC) by six wickets at Vadodara. Powered by a breathtaking partnership between Smriti Mandhana and Georgia Voll, the match went down to the final over, sealing **RCB's second WPL title** and extending Delhi Capitals painful run of final defeats.

**Key Highlights Of WPL Final 2026**

- **Delhi Capitals Post a Huge Total:** Batting first, Delhi Capitals put up a formidable 203 for 4, the **second-highest first-innings score in any women's T20 final**. Jemimah Rodrigues anchored the innings with a fluent 57, while Laura Wolvaardt contributed 44.
- **Mandhana-Voll Partnership Rewrites Records:** RCB's chase looked daunting after losing an early wicket at 9 for 1, but Smriti Mandhana and Georgia Voll turned the final on its head. The duo added a sensational **165 runs off just 92 balls, the highest partnership for any wicket in WPL history**.
- **Late Drama Keeps the Final Alive:** Just when the chase seemed under control, DC struck back. Voll was dismissed for 79, followed by quick wickets of Richa Ghosh and Mandhana, leaving RCB under pressure in the final overs. From a near-certain win, the equation suddenly tightened, setting up a dramatic finish that had fans on the edge of their seats.

**Player Of the Match In WPL Final 2026**

- Smriti Mandhana was deservedly adjudged the Player of the Match for her sublime knock that anchored RCB's historic chase in the WPL 2026 final.
- Walking in after an early setback, the RCB skipper played with a perfect blend of composure and aggression, smashing 87 off just 41 balls, laced with 12 fours and three sixes.
- Her innings not only set the tempo in the record 204-run chase the highest ever in a WPL or IPL final but also dismantled Delhi Capitals' bowling under immense pressure.

**16th Finance Commission**

The balance of money between the **Centre and the States** has entered a new phase. The 16th Finance Commission, whose recommendations will apply from 2026-27 to 2030-31, has decided to retain the States' share at 41% of the divisible tax pool but has significantly altered how that share is distributed. By introducing GDP contribution as a new criterion and ending revenue deficit grants, the Commission has signalled a shift towards efficiency, growth and fiscal discipline, making this a high-importance topic for competitive exams.

**41% Tax Devolution Retained: What It Means**

- **Despite demands from 18 states to raise their share to 50%, the Commission retained the 41% devolution rate.**
- It argued that states already account for over two-thirds of total non-debt public revenues, and increasing their share further would constrain the Union government's ability to meet national obligations.
- This decision reflects **continuity with the 15th Finance Commission**, while signalling that fiscal federalism will now focus more on quality of spending rather than only higher transfers.

**GDP Contribution Added**

- A major innovation is the **introduction of State GDP contribution as a new parameter** in the **horizontal devolution formula, with a 10% weight**.
- This criterion recognizes states that contribute more to national economic growth.
- The Commission clarified that this is a directional change, not a radical shift, to balance efficiency with equity.

**Changes in Horizontal Devolution Formula**

- Along with GDP contribution, the Commission made several adjustments.
- It removed the **2.5% weight for tax effort, increased the population weight by 2.5 percentage points**, and reduced the weights for area, demographic performance, and per capita GSDP distance.
- As a result, industrialized and faster-growing states like Karnataka, Kerala, Gujarat and Maharashtra gained higher shares, while more populous and poorer states such as Uttar Pradesh and Bihar saw relative declines.
- This redistribution has major political and economic implications.

No Revenue Deficit Grants

- **For the first time, the Commission recommended zero Revenue Deficit Grants (RDGs).**
- It argued that RDGs weaken incentives for fiscal reform by encouraging dependency.
- States, it said, have sufficient scope to increase revenues and rationalise expenditure.
- This is a major departure from earlier Finance Commissions and reflects a strong push towards self-reliance and fiscal responsibility at the state level.

Local Bodies and Disaster Management Funding

- While cutting RDGs, the Commission earmarked ₹7.91 trillion for rural and urban local bodies over five years, with a 60:40 rural–urban split, focusing on water, sanitation and urban infrastructure.
- It also recommended ₹2.04 trillion for State Disaster Response and Mitigation Funds and ₹79,000 crore for national disaster funds, using a revamped disaster risk index.
- This shows a preference for functional, purpose-linked grants rather than general fiscal support.

**RBI MPC February 2026**

The **RBI MPC February 2026 meeting** is important for banks, borrowers, investors, and common people. In this meeting, the **Reserve Bank of India (RBI)** decided to **keep the repo rate unchanged at 5.25%** and continue with a **neutral monetary policy stance**.

The decision was taken during the **59th meeting of the Monetary Policy Committee (MPC)** held from **February 4 to 6, 2026**, under the chairmanship of **Sanjay Malhotra**, Governor of RBI.

This policy decision reflects RBI’s balanced approach towards **controlling inflation** while **supporting economic growth**.

Why RBI MPC February 2026 Is in News?

The **RBI MPC February 2026 meeting** is in news because:

- The **repo rate was kept unchanged at 5.25%**
- RBI continued its **neutral stance**
- Updated **growth and inflation projections** were released

These decisions directly affect **loan EMIs, fixed deposits, bank interest rates, and inflation expectations**.

Key Decisions of RBI Monetary Policy February 2026

After reviewing global and domestic economic conditions, the MPC **unanimously voted** to keep policy rates unchanged.

Current Policy Rates

- **Repo Rate:** 5.25%
- **Standing Deposit Facility (SDF):** 5.00%
- **Marginal Standing Facility (MSF):** 5.50%
- **Bank Rate:** 5.50%

The MPC also decided to **maintain a neutral stance**, meaning RBI will take future actions based on economic data.

What Does “Neutral Stance” Mean?

A **neutral stance** means RBI is **not committed** to either:

- Increasing interest rates, or
- Cutting interest rates

RBI will closely monitor **inflation, growth, and global conditions** before taking the next step. This gives flexibility to respond to future risks.

Global Economic Outlook

Globally, the economy showed **resilience in 2025**, supported by:

- Government spending
- Trade activity
- Supportive monetary policies

However, challenges remain:

- Geopolitical tensions
- Volatility in financial markets
- High interest rates in advanced economies

Despite these risks, global equity markets remained supported by strong investments in technology sectors.

India’s Growth Outlook

India’s economy continues to perform well despite global uncertainty.

GDP Growth Estimates

- **2025–26 GDP growth:** 7.4%
- Driven by:
  1. Strong private consumption
  2. Rising investment
  3. A strong services sector

Manufacturing activity has shown improvement, while agriculture remained resilient due to good crop output.

Future Growth Projections

- **Q1 2026–27:** 6.9%
- **Q2 2026–27:** 7.0%

RBI stated that growth risks are **evenly balanced**.

Inflation Outlook in RBI MPC February 2026

Inflation remained **very low** towards the end of 2025.

- CPI inflation was **0.7% in November** and **1.3% in December 2025**
- Food prices stayed in deflation
- Core inflation remained under control

India AI Impact Summit 2026: Global AI Leadership on Display

The India AI Impact Summit 2026 brought together,

- Representatives from 100+ countries
- Over 20 Heads of State and Government
- Around 60 Ministers and Vice Ministers
- 500+ global AI leaders and CEOs

Prime Minister Narendra Modi stated that hosting the world's largest AI summit is a moment of pride for India and the Global South.

Artificial Intelligence: A Turning Point in Human Civilization

- PM Modi compared AI's emergence to historic milestones like the invention of **fire**, **writing** and **wireless communication**.
- He said Artificial Intelligence represents a transformation of similar magnitude.
- He stressed that while machines are becoming intelligent, AI's real power lies in multiplying human capability.

Cabinet Approvals

- On **13 February 2026**, the Hon’ble Prime Minister dedicated the new **Prime Minister’s Office**, now named ‘**Seva Teerth**’, marking a historic shift from the colonial-era **South Block**. The transition symbolizes India’s movement from a legacy of colonial governance to a culture of **service-oriented administration** aligned with the vision of **Viksit Bharat @2047**. The Union Cabinet also resolved to convert **North and South Blocks** into the “**Yuge Yugeen Bharat National Museum**”, celebrating India’s civilizational heritage.
- The Cabinet approved the establishment of the **Startup India Fund of Funds 2.0 (FoF 2.0)** with a corpus of **₹10,000 crore** to mobilize long-term domestic capital and strengthen India’s venture capital ecosystem. Building upon the success of **FFS 1.0**, which supported **145 AIFs** and enabled investments of over **₹25,500 crore in 1,370+ startups**, FoF

- 2.0 will prioritize **deep-tech, innovative manufacturing, early-stage founders, and nationwide inclusion**. The initiative aligns with India’s innovation-led growth strategy and aims to generate high-quality jobs while enhancing economic resilience.
- The Cabinet also approved the launch of the **Urban Challenge Fund (UCF)** with **₹1 lakh crore Central Assistance**, expected to catalyze total investments of **₹4 lakh crore** over five years. Operational from **FY 2025–26 to FY 2030–31**, the Fund mandates at least **50% market-based financing**, encouraging municipal bonds, PPPs, and private investment. With a dedicated **₹5,000 crore Credit Repayment Guarantee Scheme** for smaller and northeastern cities, UCF focuses on **Cities as Growth Hubs, Creative Redevelopment, and Water & Sanitation**, promoting climate-responsive and outcome-based urban infrastructure.

- The Cabinet Committee on Economic Affairs (CCEA) approved multiple national highway projects to enhance connectivity and economic growth. In **Maharashtra**, the **Ghoti–Trimbak–Jawhar–Manor–Palghar (NH-160A)** corridor of **154.635 km** was sanctioned at a cost of **₹3,320.38 crore (EPC mode)**, connecting major expressways including the **Delhi–Mumbai Expressway** and generating nearly **44.84 lakh person-days of employment**. In **Gujarat**, construction of **107.67 km of NH-56** at **₹4,583.64 crore (HAM mode)** will improve tribal connectivity and reduce travel time by **40%**. In **Telangana**, widening of **NH-167 (80.01 km)** at **₹3,175.08 crore (HAM mode)** will enhance freight efficiency and regional integration.
- A landmark infrastructure project was approved in **Assam**, involving a **33.7 km 4-lane greenfield corridor** from **Gohpur to Numaligarh**, including a **15.79 km twin-tube underwater road-cum-rail tunnel under the Brahmaputra River**, at a cost of **₹18,662 crore (EPC mode)**. This will be India's **first underwater road-cum-rail tunnel** and is expected to generate **80 lakh man-days of employment**, significantly improving connectivity in the Northeast.
- Additionally, three major **railway multi-tracking projects—Kasara–Manmad, Delhi–Ambala, and Ballari–Hosapete—**were approved at a total cost of **₹18,509 crore**, adding **389 km** to the rail network across **Delhi, Haryana, Maharashtra, and Karnataka**. These projects will improve freight capacity by **96 MTPA**, reduce logistics costs, save **22 crore litres of fuel**, and lower **CO<sub>2</sub> emissions by 111 crore kg**, contributing to India's climate goals and enhancing connectivity to key industrial and tourist hubs.
- The **Union Cabinet**, chaired by **Prime Minister Narendra Modi**, approved the proposal to change the name of the State of **“Kerala” to “Keralam”** under **Article 3 of the Constitution of India**. After Cabinet approval, the **President of India** will refer the **Kerala (Alteration of Name) Bill, 2026** to the **Kerala Legislative Assembly** for expressing its views. Once the Assembly's views are received, the Bill will be introduced in **Parliament** with the President's recommendation. The Kerala Legislative Assembly had earlier passed a unanimous resolution on **24 June 2024** requesting the name change, stating that **“Keralam”** reflects the state's linguistic identity. As per **Article 3**, Parliament has the authority to alter the name of a state, but such a Bill must be referred to the concerned State Legislature before introduction.
- The **Cabinet Committee on Economic Affairs (CCEA)** approved enhanced delegation of powers to **POWERGRID**, increasing its permissible equity investment limit from **₹5,000 crore to ₹7,500 crore per subsidiary**, while retaining the cap of **15% of net worth**. This approval enables POWERGRID to participate in large transmission projects such as **UHVAC and HVDC networks**, support evacuation of renewable energy, and help achieve India's target of **500 GW non-fossil capacity**. It also strengthens competition under **Tariff Based Competitive Bidding (TBCB)**, ensuring better price discovery and affordable clean energy.
- The CCEA also approved the development of a new **Civil Enclave at Srinagar International Airport** at an estimated cost of **₹1,677 crore**. The project, spread over **73.18 acres**, will include a modern terminal building of **71,500 sq. meters**, designed to handle **10 million passengers per annum (MPPA)** and 2,900 peak-hour passengers. The expanded apron will accommodate **15 aircraft bays**, including one widebody (Code E). The project aims for a **5-star GRIHA rating** and will enhance tourism and connectivity in the Kashmir Valley.
- Further, the CCEA approved **three Railway projects** costing **₹9,072 crore**, namely **Gondia–Jabalpur Doubling, Punarakh–Kiul 3rd & 4th line, and Gamharia–Chandil 3rd & 4th line**. These projects will add approximately **307 km** to the railway network, improve connectivity to **5,407 villages (98 lakh population)**, and enhance freight capacity by **52 MTPA**. The expansion will reduce oil imports by **6 crore litres** and cut CO<sub>2</sub> emissions by **30 crore kg**, aligning with the **PM Gati Shakti National Master Plan**.
- The CCEA also approved the **Minimum Support Price (MSP) of Raw Jute (TD-3 grade)** for the **Marketing Season 2026–27** at **₹5,925 per quintal**, ensuring a **61.8% return over cost of production**. This represents an increase of **₹275 per quintal** over the previous season. Since 2014–15, MSP for jute has increased from **₹2,400 to ₹5,925 per quintal**. The **Jute Corporation of India (JCI)** will continue as the nodal agency for price support operations.
- Additionally, the Union Cabinet approved the **Ahmedabad Metro extension from GIFT City to Shahpur**, spanning **3.33 km with three elevated stations**, at a cost of **₹1,067.35 crore**. The project will be implemented by **Gujarat Metro Rail Corporation Limited (GMRC)**, a 50:50 joint venture between the Centre and the Gujarat Government. The extension is expected to benefit **23,702 passengers by 2029** and **58,059 passengers by 2041**, strengthening connectivity between Ahmedabad and GIFT City.

The publication provides a detailed assessment of global and domestic trade trends and includes a thematic focus on India’s electronics trade.

Key Findings: Trade Performance in Q2 FY26

- India’s exports (services + merchandise) grew by **~8.5%**.
- Export growth outpaced imports, sustaining trade expansion.
- Global trade growth moderated but remained positive.
- Services continued to outperform goods globally.

The report also highlights that trade among developing economies has expanded nearly **fourfold since 2005**, aligning with India’s growing integration with the Global South.

**Global Corruption Perceptions Index 2025**

The **Corruption Perceptions Index 2025** released by **Transparency International** presents a worrying picture. **The global average score has declined**, and fewer countries now fall into the **“very clean” category**. In the Corruption Perceptions Index 2025, Denmark once again leads, while conflict-affected nations dominate the bottom ranks.

Corruption Perceptions Index 2025: Global Trend Turns Negative

- The [Corruption Perceptions Index 2025](#) evaluated **182 countries based on perceived public sector corruption**.
- **Scores range from 0 (highly corrupt) to 100 (very clean)**.
- This year’s findings indicate a **global average score of 42**, the lowest in more than a decade.
- Notably, **122 countries scored below 50**, highlighting that corruption concerns remain widespread.
- Transparency International also observed that the number of countries scoring above 80 has sharply declined over the years.
- This signals governance challenges even in traditionally strong democracies.

Least Corrupt Countries in Corruption Perceptions Index 2025

According to the Corruption Perceptions Index 2025, Denmark retained the top rank with a score of 89, extending its impressive streak. The top performers include,

1. **Denmark** – 89 (Maintaining Its 8 Years Streak to Sit at Top)
2. **Finland** – 88
3. **Singapore** – 84
4. **New Zealand** – 81
5. **Norway** – 81

These countries are recognized for strong institutions, transparency, and low levels of public sector corruption.

However, the report clarifies that even high-scoring nations are not corruption-free, as **some have shown declining trends in recent years**.

Most Corrupt Countries in Corruption Perceptions Index 2025

At the bottom of the Corruption Perceptions Index 2025, countries facing conflict, instability, and weak governance structures dominate,

- **South Sudan** – Score 9 (Rank 181)
- **Somalia** – Score 9 (Rank 181)
- **Venezuela** – Score 10 (Rank 180)

Low scores typically reflect fragile state institutions, political instability, and restricted civil liberties. Such countries often struggle with rule of law and accountability mechanisms.

CPI 2025 India Rank: Where Does India Stand?

In the Corruption Perceptions Index 2025, **India ranked 91st globally**, securing a **CPI score of 39 out of 100**. This marks a slight improvement compared to the previous year. While India remains below the global average of 42, the ranking suggests incremental progress in governance and transparency reforms.
